Pursuant to COGCC Rule 603.a.(2), Encana Oil & Gas (USA) Inc. (Encana) hereby requests administrative approval for an exception to COGCC Rule 603.a.(2) which sets forth that a well shall be a minimum distance of one hundred fifty (150) feet from a surface property line.

Encana is the owner of the oil and gas lease covering the captioned lands and plans to drill the referenced well on a new well pad. The subject well is staked at a location 100 feet from a surface property line to the north. Encana has obtained a signed waiver from the encroached-upon landowner. 
