Closest Water well permit #: 28937/A pre spud rig may be utilized to drill and set surface casing. This rig is not capable of using a closed loop system. Therefore, two small working pits will be required to capture the cuttings and fluids. If a working pit is used on a PAD located within a sensitive area as marked on the 2A, the pits will be lined with 16M liner/The surface location of this well is an exception to Rule 318A.a and to Rule 318A.c. This well is not within the GWA surface location window and does not meet the twinning requirement due to the number of wells planned for this area and at the request of the surface owner. An exception location request letter and signed waivers are attached to the Form 2 and Form 2A.
