FACILITIES: Total proposed wells to be drilled from this pad are 11- 2 existing well which are the Great Western #25-22 -API #05-123-31722-00, #25-52-API #05-123-31721-00. Surface owner and Mineral are owned by Broe Land Acquisitions II. (Surface: Great Western Oil & Gas Co., LLC and Minerals: Broe Land Acquisitions II. Nearest water well referenced is permit #113762. There is an abandoned location for #113762 about 1000' SE of location, and the actual operating water well with the same permit number is 1670' SE of proposed location, but no static water level is available to reference. Water well permit #276998 is located about 1600' SE of location with a 14' static water level indicated. Rule 604.a. (4) - Tank Battery will comply. Rule 604.a. (2) - each condensate tank measures 12' diameter.
