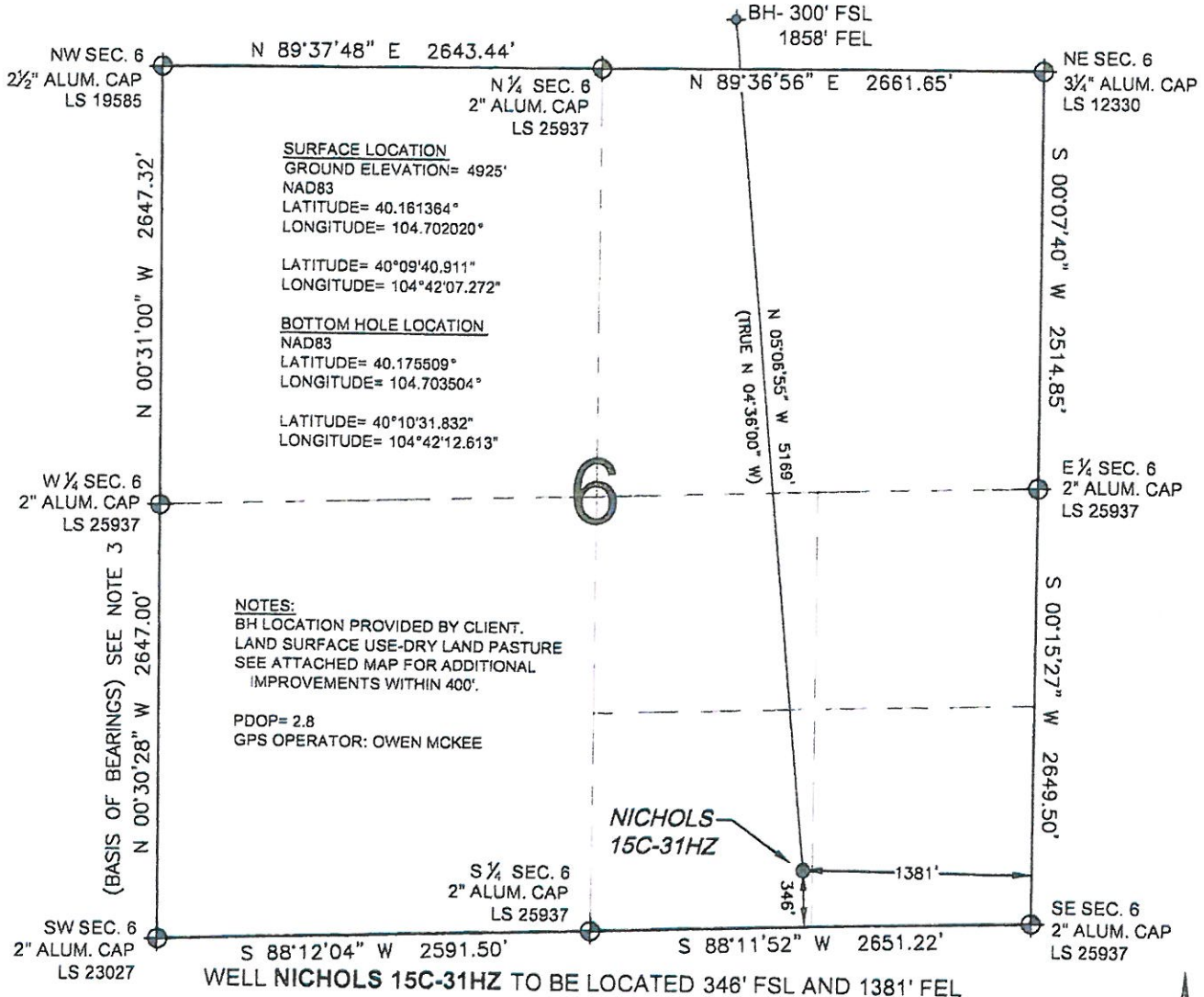


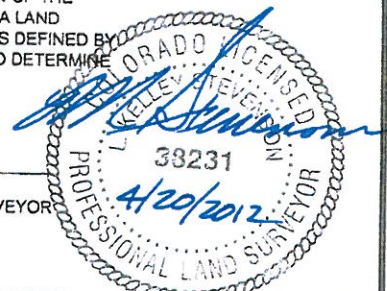

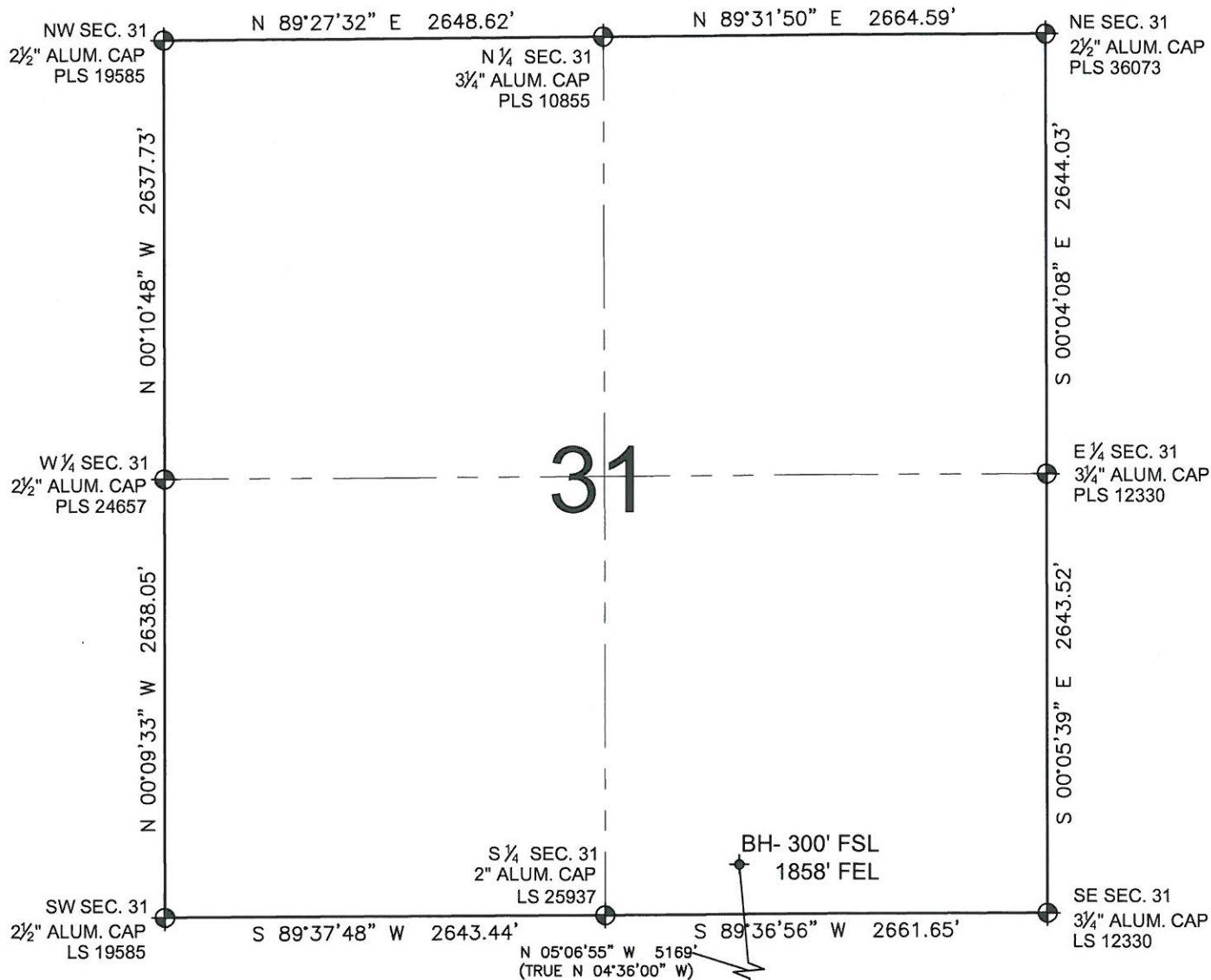

# WELL LOCATION CERTIFICATE: NICHOLS 15C-31HZ



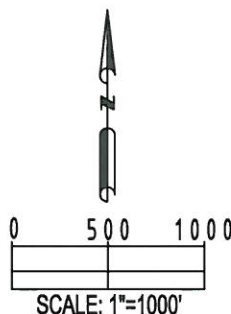
