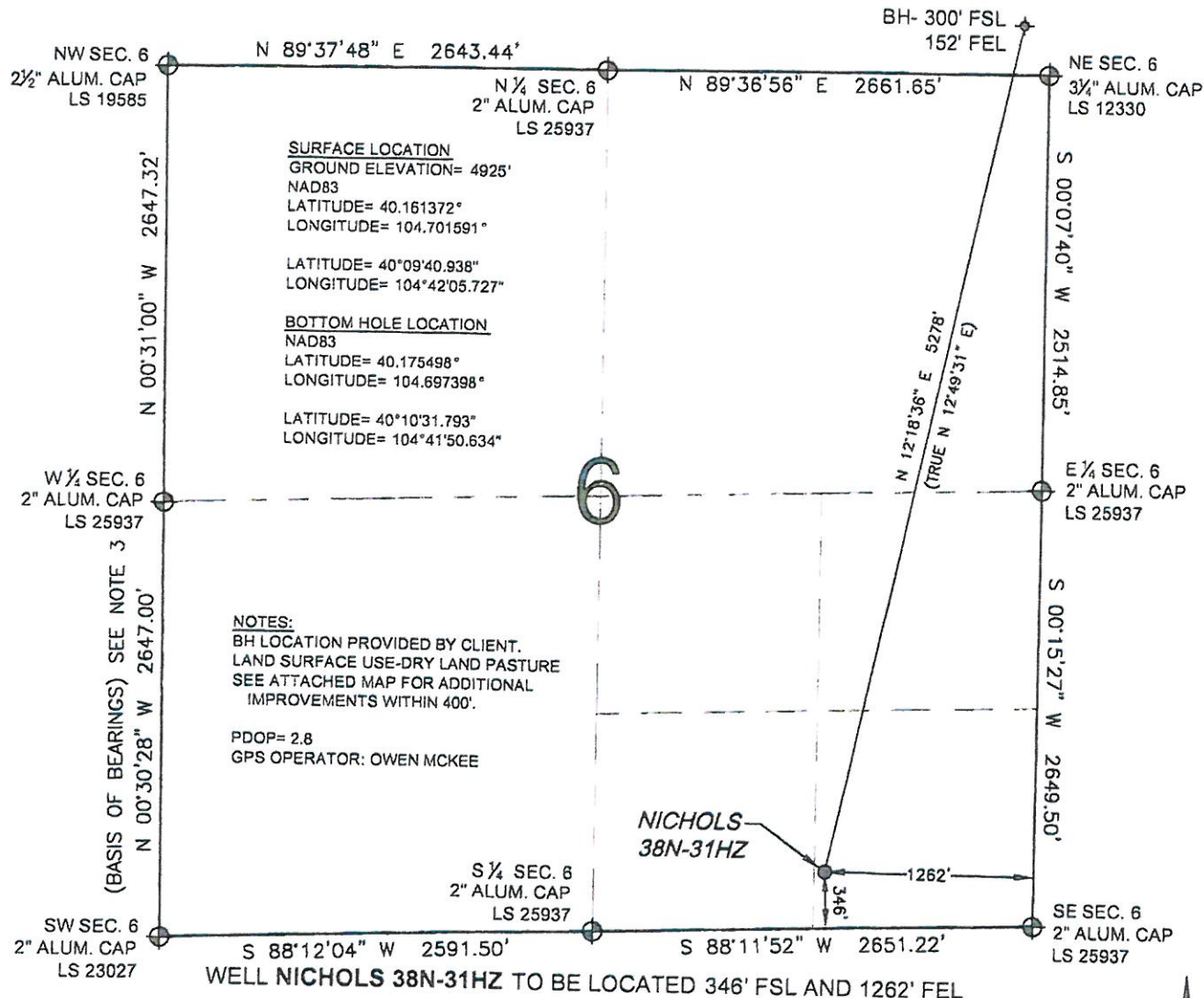


# WELL LOCATION CERTIFICATE: NICHOLS 38N-31HZ

- ⬢ = EXISTING WELL

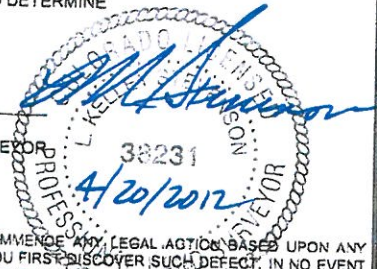

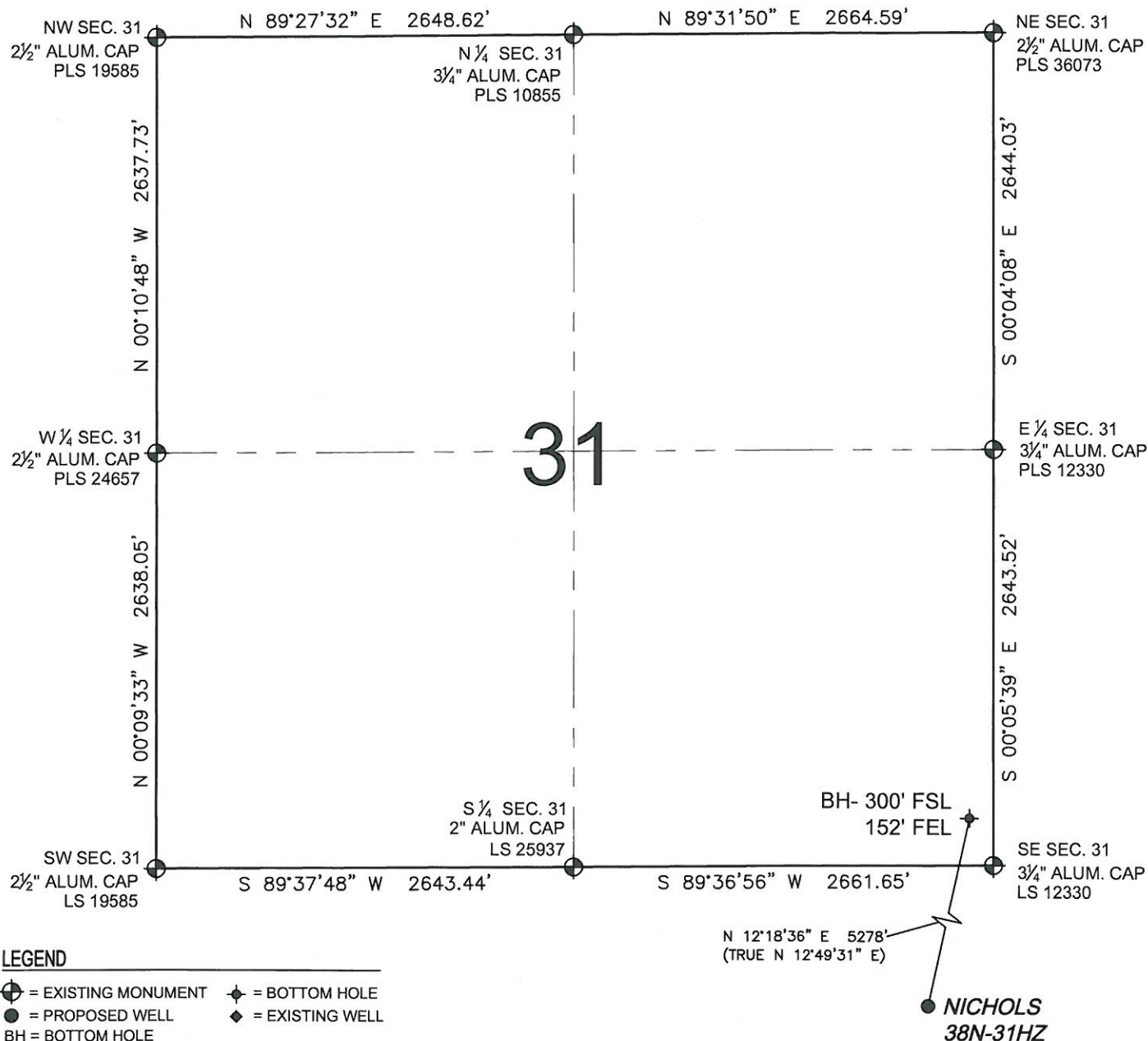
