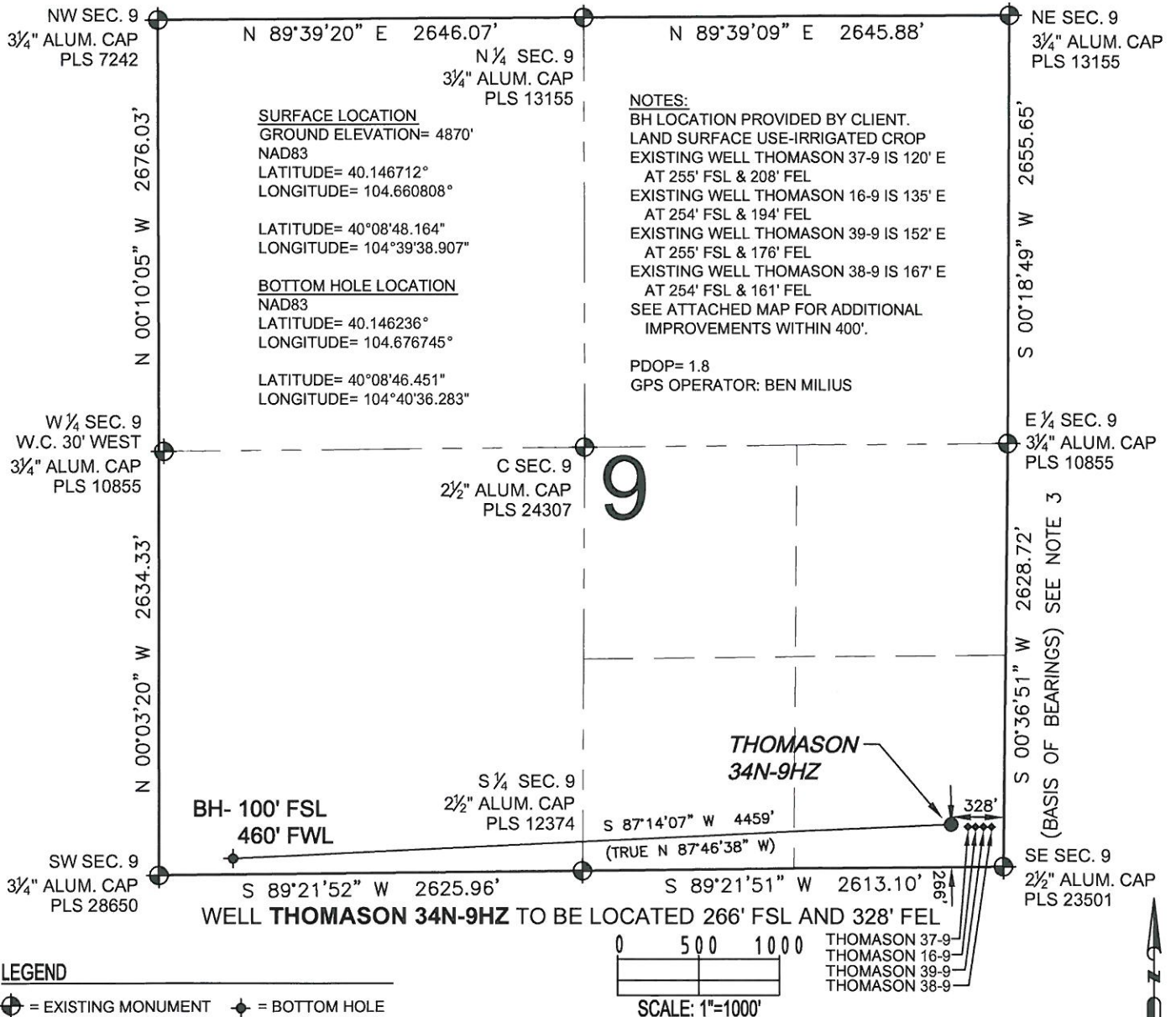


# WELL LOCATION CERTIFICATE: THOMASON 34N-9HZ
