Alex and Annie,

I will use the spill tracking number, location id, and REM# on future submittals. I ordered the hydrocarbon cleaner from Earth Smart this morning. According to Earth Smart, it will clean hydrocarbon spills off of any surface that is compatible with water and it also contains nutrients to aid in bioremediation. As soon as it comes in, I will schedule the application. Earth Smart said that it may take one to two applications depending on the viscosity of the oil.

I expect that the first application will be done before the end of May and a second application (if necessary) may be performed in June 2012. Subsequent sampling will be dependent on how well

the solution removes the hydrocarbons from the vegetation, but it will be conducted in July or August 2012 in order to give the soil microbes time to degrade the DRO hydrocarbons during the short growing season. A report will be prepared to document the results.
