LTE would like to submit the following No Further Action determination request on behalf of PDC. Please review the attached supporting documentation for activities associated with a failed weld on a production tank at the above referenced subject site located in the C/SW Section 35-T7N-R66W. Soil and groundwater were impacted at the site from the release. Approximately 440 cubic yards of impacted soil and 180 bbls of impacted water were removed from the site and transported to licensed disposal facilities. Analytical results indicated that the final extent of the excavation associated with the release were in compliance with COGCC Table 910-1 Concentration Levels. Activated carbon was applied to the excavation before backfilling activities to remediate residual hydrocarbons. Monitoring wells were installed in April 2011. Groundwater samples were collected on a quarterly basis until analytical data was in compliance with CDPHE Regulation 41 Standards for four consecutive quarters.

As four consecutive quarters of CDPHE Reg 41 compliant groundwater analytical results have been achieved, PDC is requesting a No Further Action determination for this site.
