The Magnuson 23I-221, Magnuson 23I-421, Magnuson 23L-201, and Magnuson 23L-421 will be drilled from this pad. The Magnuson 23I-201 was permitted on location ID 428204, but has been moved to this location. Sundries have been mailed.
