Bill Barrett Corporation (BBC) is planning to drill the above mentioned well to the Niobrara formation.

The surface location of BBC's proposed well has been staked outside of the 318A.a drilling window. The location is being permitted as an exception location. BBC has obtained written permission contained in a waiver from the surface owner.

Under revised Rule 318A.c any new twinning well is to be located within 50' of an existing well. The surface location of BBC's proposed well has been staked approximately 1117' from the nearest oil & gas well. BBC has obtained permission, contained in a waiver, from the surface owner.

70 Ranch, L.L.C., owner of the Subject Lands, for adequate consideration, the receipt and sufficiency of which is hereby acknowledged does hereby waive the provisions of Rule 318.A.(a) of the Colorado Oil and Gas Conservation Commission's Rules Regulations that provides that wells shall be drilled within a square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' Window"). 70 Ranch, L.L.C. hereby consents and authorizes Bill Barrett Corporation to drill, complete and operate the following wells:

70 Ranch 4-63-3-32H being 2014 feet FSL and 427 feet FEL of Section 3, Township 4 North, Range 63 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 33 feet outside of the 400' Window of Subject Lands.

70 Ranch 4-63-3-33H being 1991 feet FSL and 427 feet FEL of Section 3, Township 4 North, Range 63 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 33 feet outside of the 400' Window of Subject Lands.

70 Ranch 4-63-3-48H being 1969 feet FSL and 426 feet FEL of Section 3, Township 4 North, Range 63 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 34 feet outside of the 400' Window of Subject Lands.

70 Ranch 4-63-3-49H being 1946 feet FSL and 425 feet FEL of Section 3, Township 4 North, Range 63 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 35 feet outside of the 400' Window of Subject Lands.

By signing this letter you hereby grant your consent to Bill Barrett to locate the wells outside of a GWA window as defined by COGCC Rule 318A.(a). Additionally, the wells are being proposed at a surface location which is approximately 1430 feet from an existing surface well location. By signing this letter you also grant your consent to Bill Barrett Corporation to locate the wells more than 50 feet from the existing wells as provided for under COGCC Rule 318A.(c).

This waiver and authorization is signed as of the date of the acknowledgment below, but is effective for all purposes as of the Effective Date stated above.
