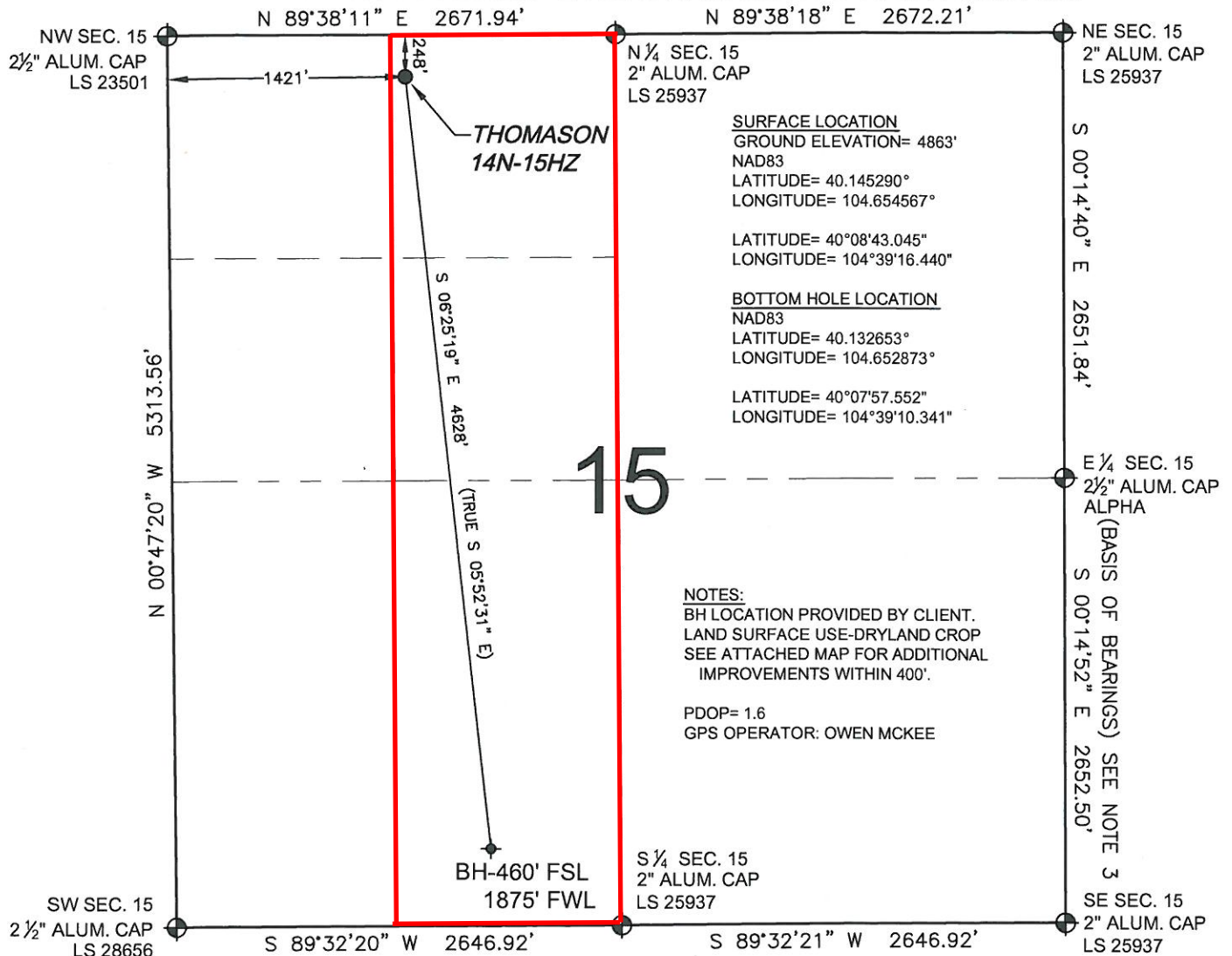

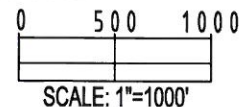
## WELL LOCATION CERTIFICATE: THOMASON 14N-15HZ

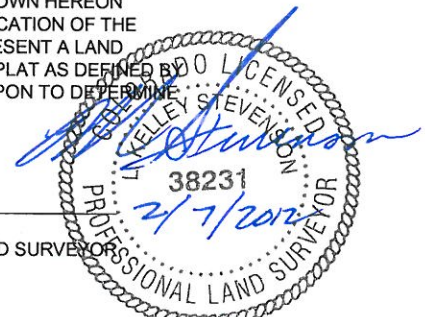
