CORRECTIVE ACTION

The well was shut in, earth berms were built around the spill area, a roustabout crew and vac truck were called to location. Approx. 6 bbls of oil were recovered. On location, the contaminated soil was removed and disposed of at Buffalo Ridge.

Describe any emergency pits constructed:
Earth berms were constructed around the spill area.

How was the extent of contamination determined:
Ground Staining

Further remediation activities proposed (attach separate sheet if needed):
On Location: contaminated material was removed and new fill material placed. Off location: S200 (bionutrient) will be sprayed on stained soil.

Describe measures taken to prevent problem from reoccurring:
All the pop-offs on all the tank batteries will be tied into the dump lines going to the production tanks.


