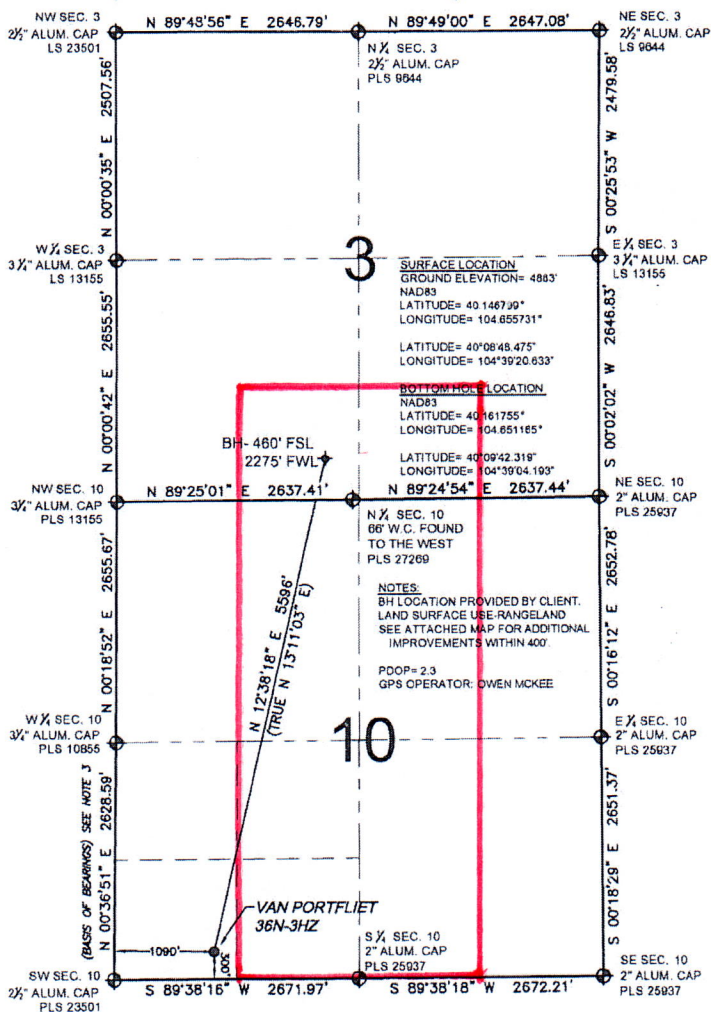

WELL LOCATION CERTIFICATE: VAN PORTFLIET 36N-3HZ

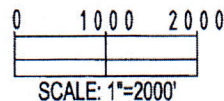

- BH = BOTTOM HOLE

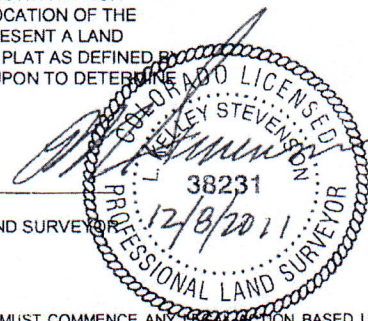
