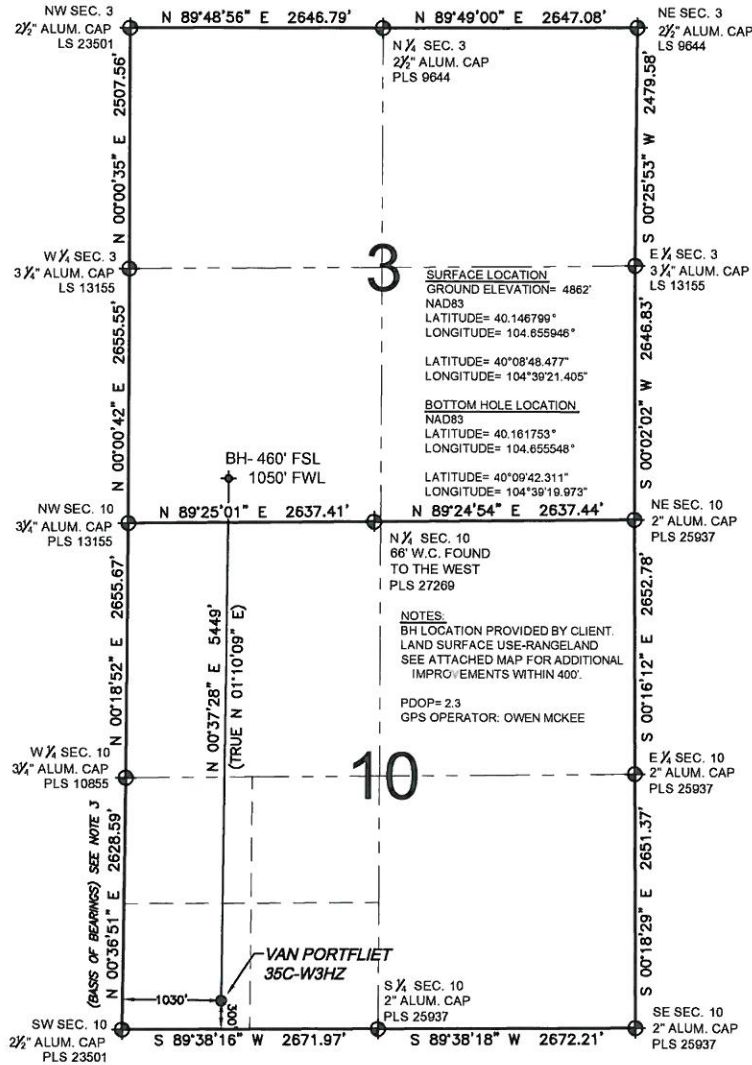


WELL LOCATION CERTIFICATE: VAN PORTFLIET 35C-W3HZ

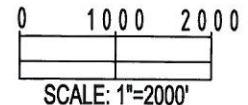
