Closest water well permit #: 46498 BMP:Cook 15-10HZ - Kerr-McGee will create secondary containment by constructing an earthen berm between the PAD site and the Beebe Seep Canal, located approximately 250' W of the PAD site to further protect the surface water. The surface location of this well is an exception to Rule 318A.a and to Rule 318A.c. This well is not within the GWA surface location window and does not meet the twinning requirement due to the number of wells planned for this area and at the request of the surface owner. An exception location request letter and signed waivers are attached to the Form 2 and Form 2A.
