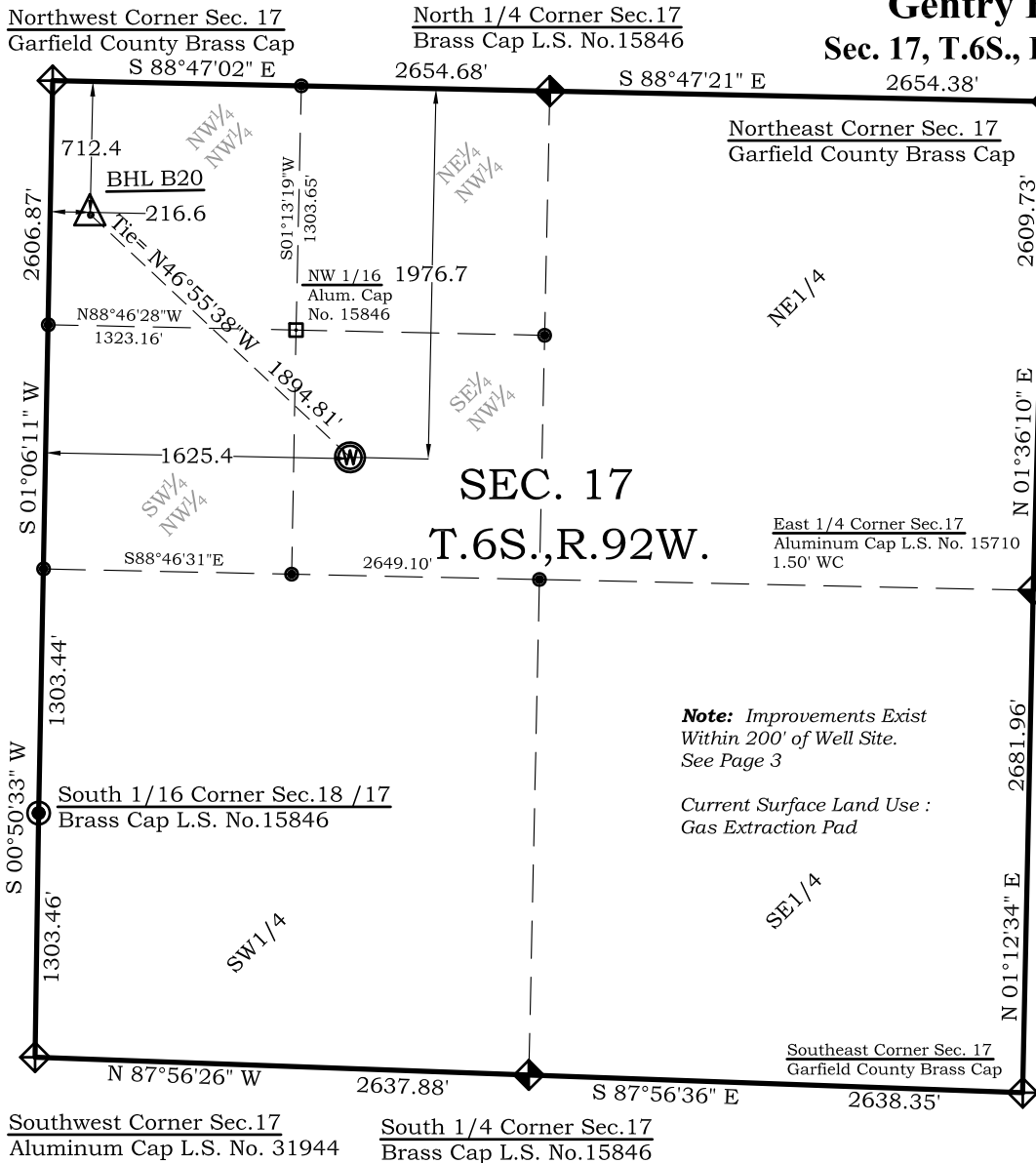


Well Location Plat

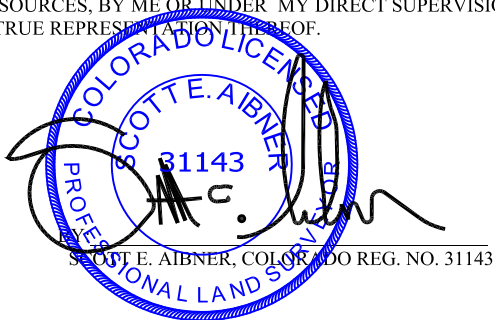
