Bob,

Hi. I am glad to receive your contact information; I have not had a contact since Harold left. I apologize for the email communication, but I am not in a position today to make phone calls and will be out of the office for the next several days. However I wanted to respond to you regarding the processing of this sundry.

This Fram sundry requests a "variance" for ec levels and consideration of background for the arsenic levels. Our rules require that in the case of a request for a "variance", CDPHE must be consulted, the Director must approve the variance, and my understanding is that very few if any have been approved. The time required for a variance to be approved is significant also.

I don't see the depth of sample collection for the pit sample. EC concentrations are most important within the upper 3 feet, because they affect vegetative regrowth. The depth at which the pit sample was collected is important in considering approval of this sundry.

Before requesting a "variance" (if the pit sample was collected at a depth less than 3 feet), a quicker approach might be to collect some background samples for ec to demonstrate that the pit sample falls with 2 times background, as is allowed by Table 910-1. I would suggest that Fram withdraw this sundry and resubmit it with request for either a "waiver" or "consideration of background in lieu of Table 910-1 levels" for both arsenic and ec. We request that a little background study, similar to the arsenic background study, be included to support the request for ec; we typically suggest 3-5 discrete samples, from a similar depth (if possible) as the pit samples with elevated ec.

When you resubmit the sundry, please email it to this email account: ogcc.envirosundry@state.co.us. By using this account, the sundry will be routed to the appropriate queue. I will be on vacation soon, but others will have access to the sundries while I am gone if you use this address.
