Gasco has set a CIBP at 2280' and placed 35' of cement on top of plug
A 100 ft. cement plug was circulated across the casing leak at 1245-1275'
A 30 sx cement plug was spotted across the casing shoe in the 5 1/2" casing at 180'
180' of 1 1/4" tubing was run down the outside of the 5 1/2" casing and two 30 sx plugs were pumped.
The wellhead was removed and a 10 sx plug was pumped at surface with a surface marker welded in place.

Will Lambert with the BLM was on location.
