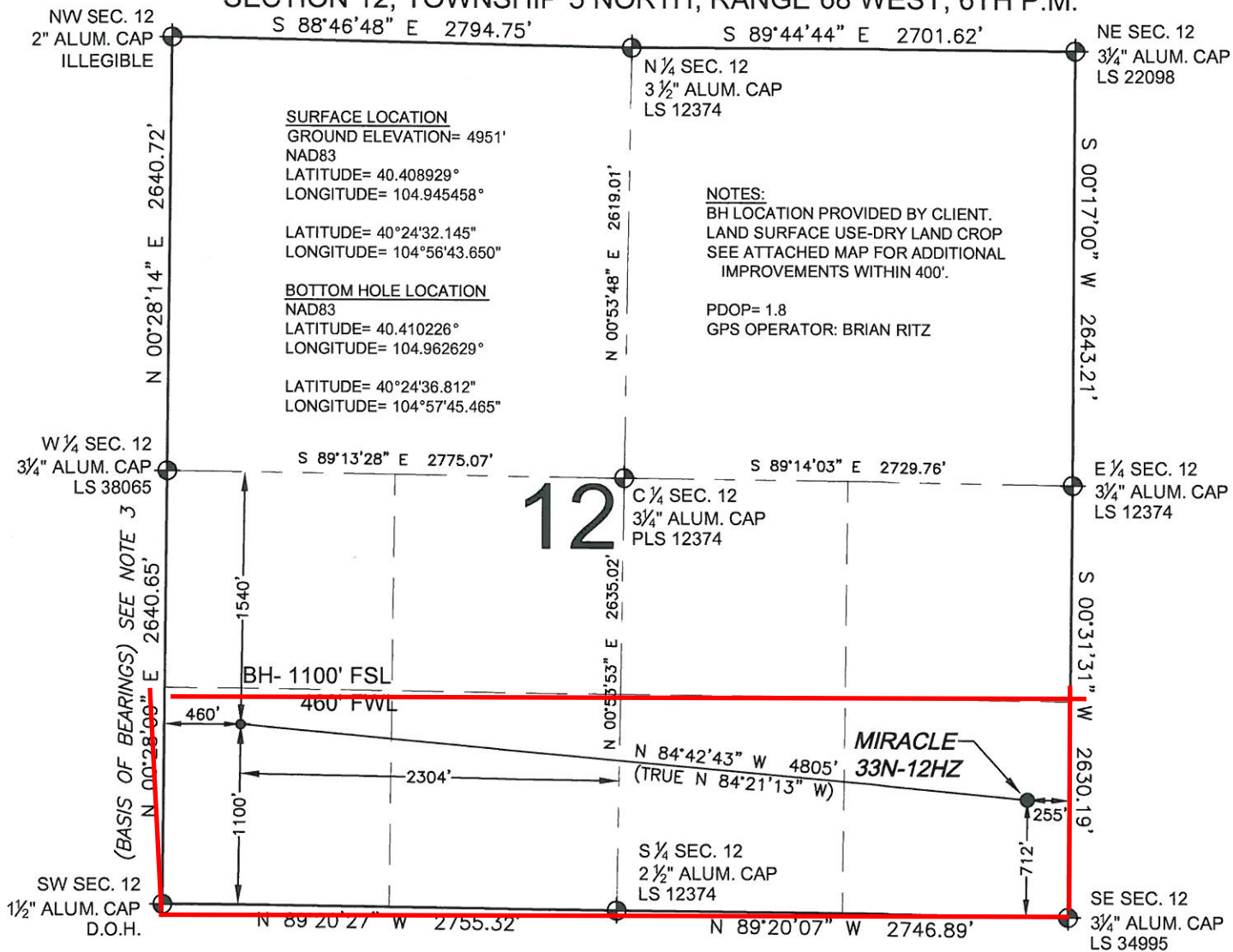

WELL LOCATION CERTIFICATE: MIRACLE 33N-12HZ

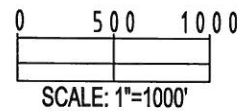
