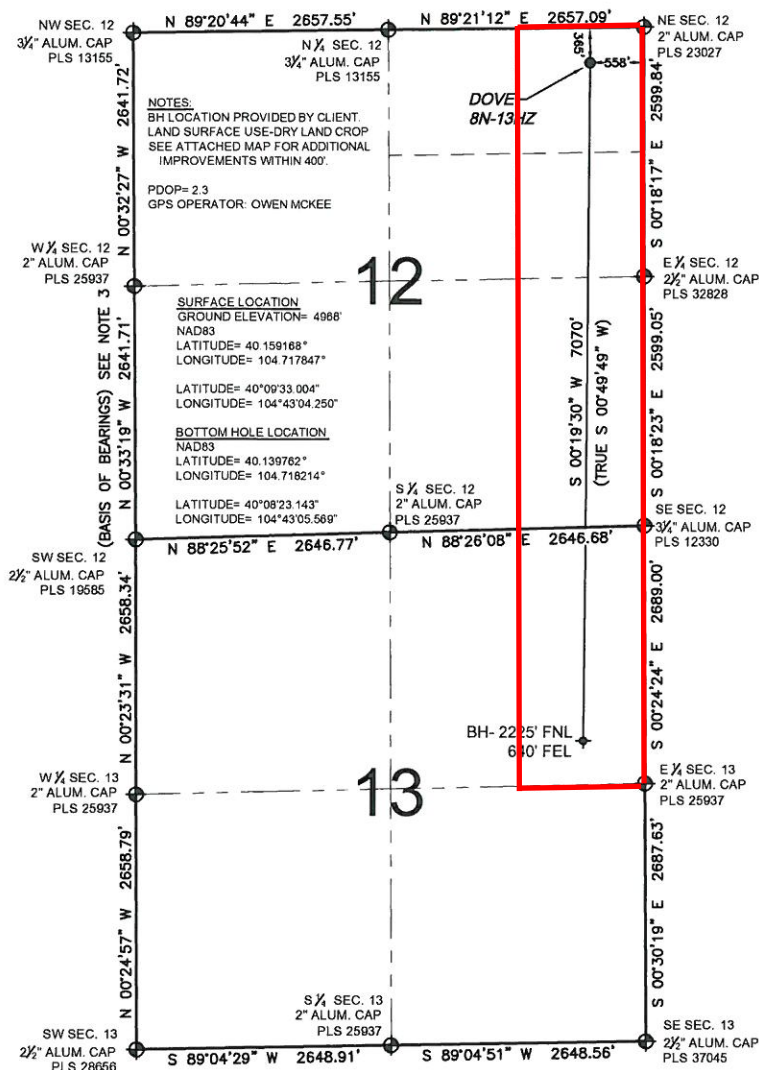

PROPOSED SPACING UNIT

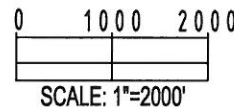
WELL LOCATION CERTIFICATE: DOVE 8N-13HZ
