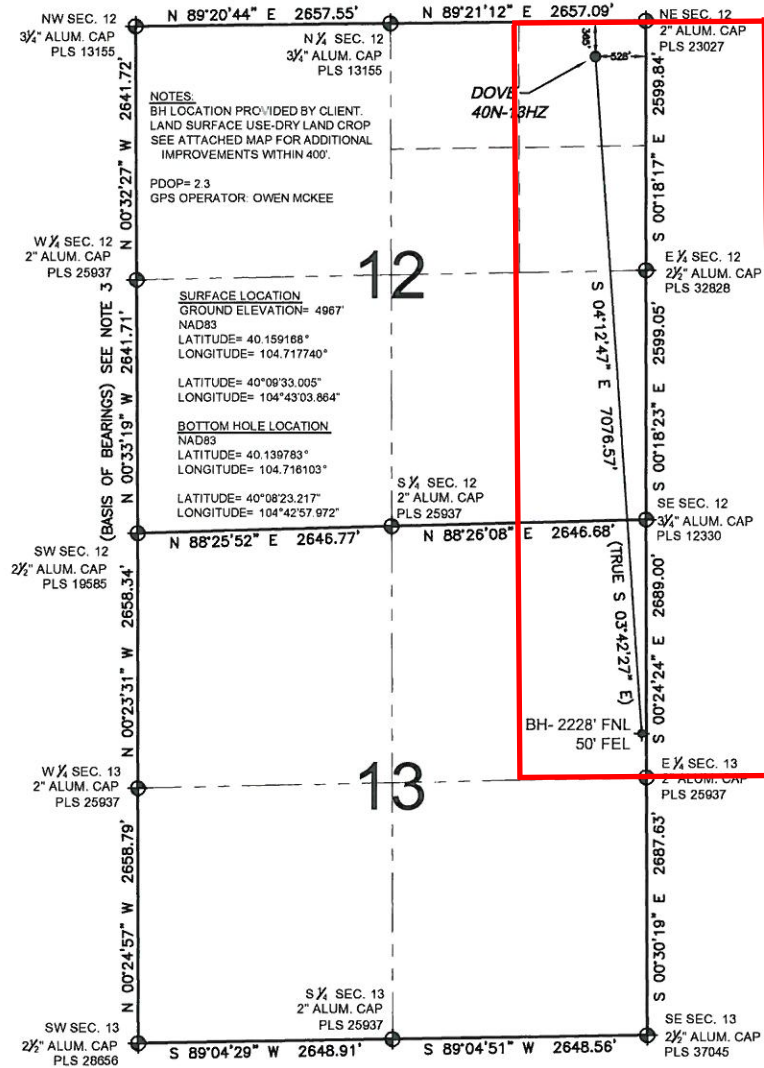

## WELL LOCATION CERTIFICATE: DOVE 40N-13HZ

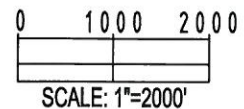
