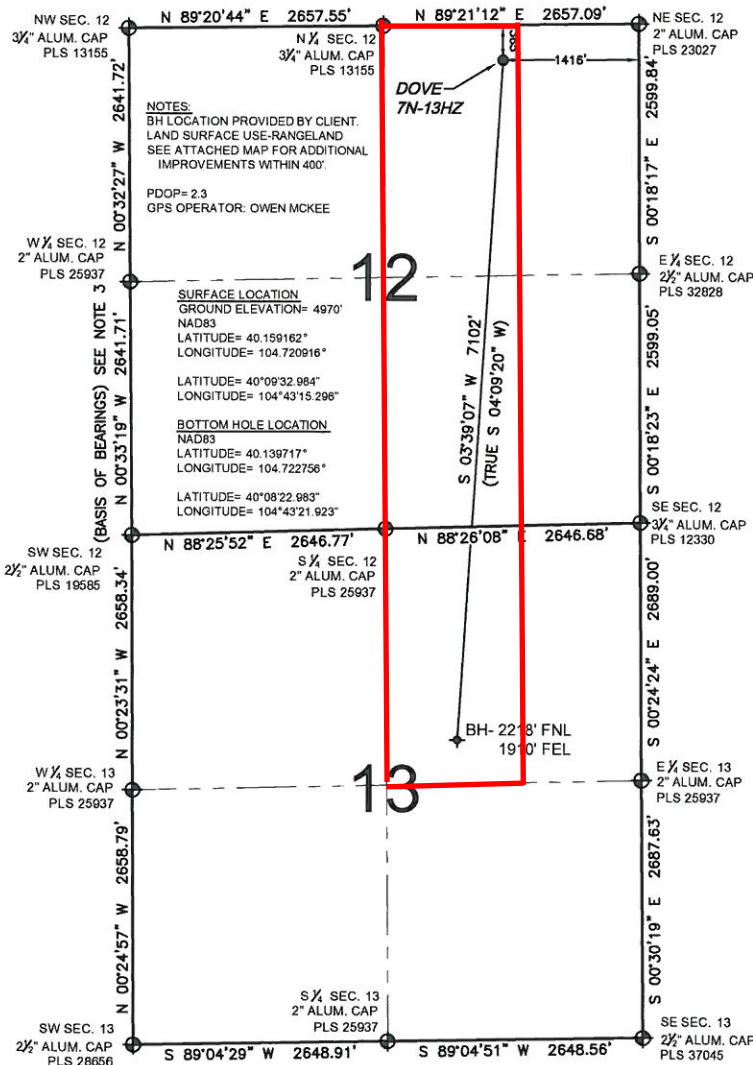

WELL LOCATION CERTIFICATE: DOVE 7N-13HZ

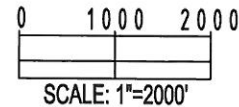

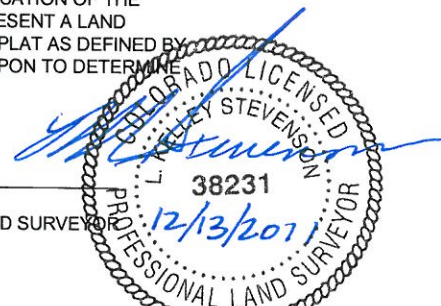
