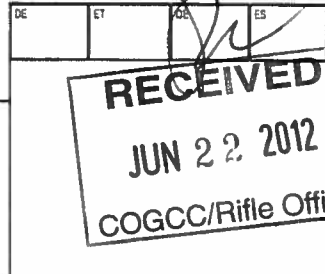

5. DESCRIBE PROPOSED OR COMPLETED OPERATIONS

WPX Energy Rocky Mountain, LLC requests permission to vent bradenhead pressure until Thursday June 28, 2012. We will then shut in the well and record the bradenhead pressure. At that time we will evaluate and plan for further completion operations.

SG 14-27 (API 05-045-21022)

- This is a newly drilled well with completion operations scheduled to start on July 2, 2012.
- Top of cement was called at 1898'
- The geologist pick for top of Mesa Verde was (2271')
- The geologist pick for top of gas was (3544')
- Observed Bradenhead pressure 200 psi.
