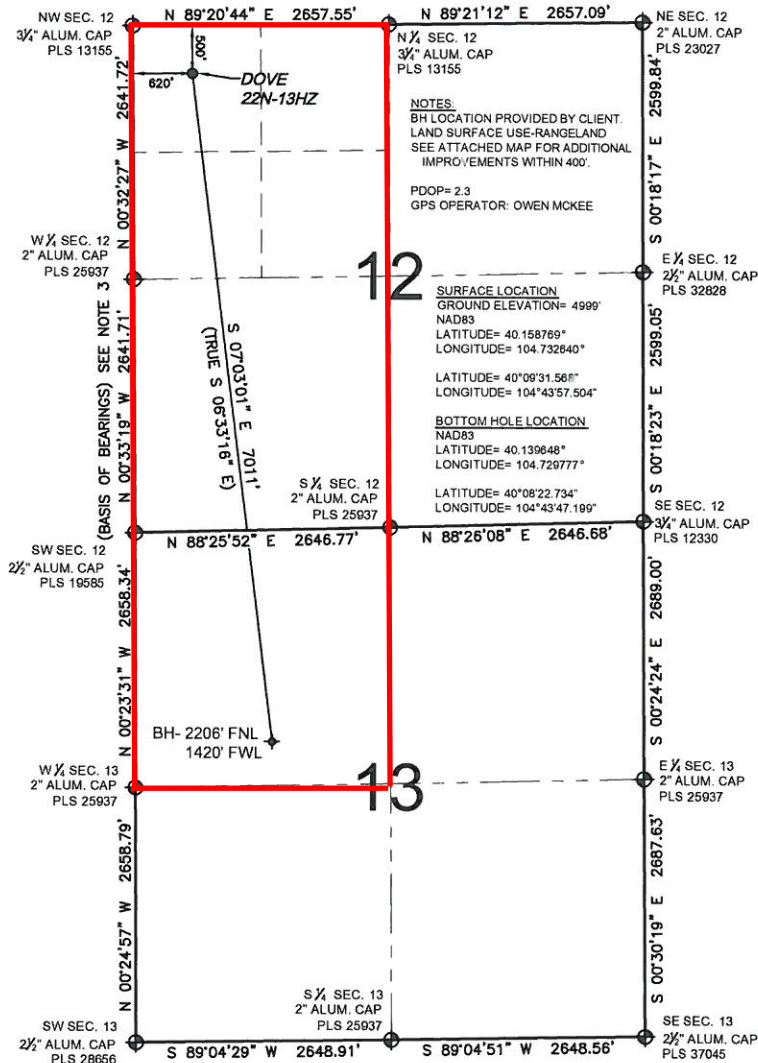

## WELL LOCATION CERTIFICATE: DOVE 22N-13HZ

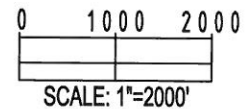
