Creating a 160 acre wellbore spacing unit. Bayswater is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within the said proposed spacing unit as required under COGCC Rule 318A.e(6). 

PROPOSED 318 Ae SPACING UNIT


SECTION 23, TOWNSHIP 7 NORTH, RANGE 65 WEST, 6TH P.M.
