- NENW, Section 23, T7 North, R65 West

Creating a 160 acre wellbore spacing unit. Bayswater is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within the said proposed spacing unit as required under COGCC Rule 318A.e(6). Copies of the required notice letter(s) is/are on file at the Bayswater offices. The required twenty (30) day notice period has elapsed absent the receipt by Bayswater of an objection to said proposal by the owner(s) within the proposed spacing unit for this well.



SECTION 23, TOWNSHIP 7 NORTH, RANGE 65 WEST, 6TH P.M.




NO EXISTING WELLS WITHIN THE PROPOSED SPACING UNIT
