These inspections will be recorded and maintained on Nighthawk's Stormwater Database/Website. Repairs shall be completed as soon as possible after an inspection reporting BMP repairs are required. Any Site specific modifications will be revised on the site plan when implemented at the site. A field wide Stormwater Management Plan (SWMP) for the Jolly Ranch Project Area is located at Nighthawk's office and can be obtained from Nighthawk's stormwater website. Spill Portection Control and Countermeasure (SPCC) plans for the Jolly Ranch Project Area are stored on file at Nighthawk's office.
