Closest Water well permit #: 58889A closed loop system will be used for all production casing drilling. However, a pre spud rig may be utilized to drill and set surface casing. This rig is not capable of using a closed loop system. Therefore, two small working pits will be required to capture the cuttings and fluids. If a working pit is used on a PAD located within a sensitive area as marked on the 2A, the pits will be lined with 16M liner.
