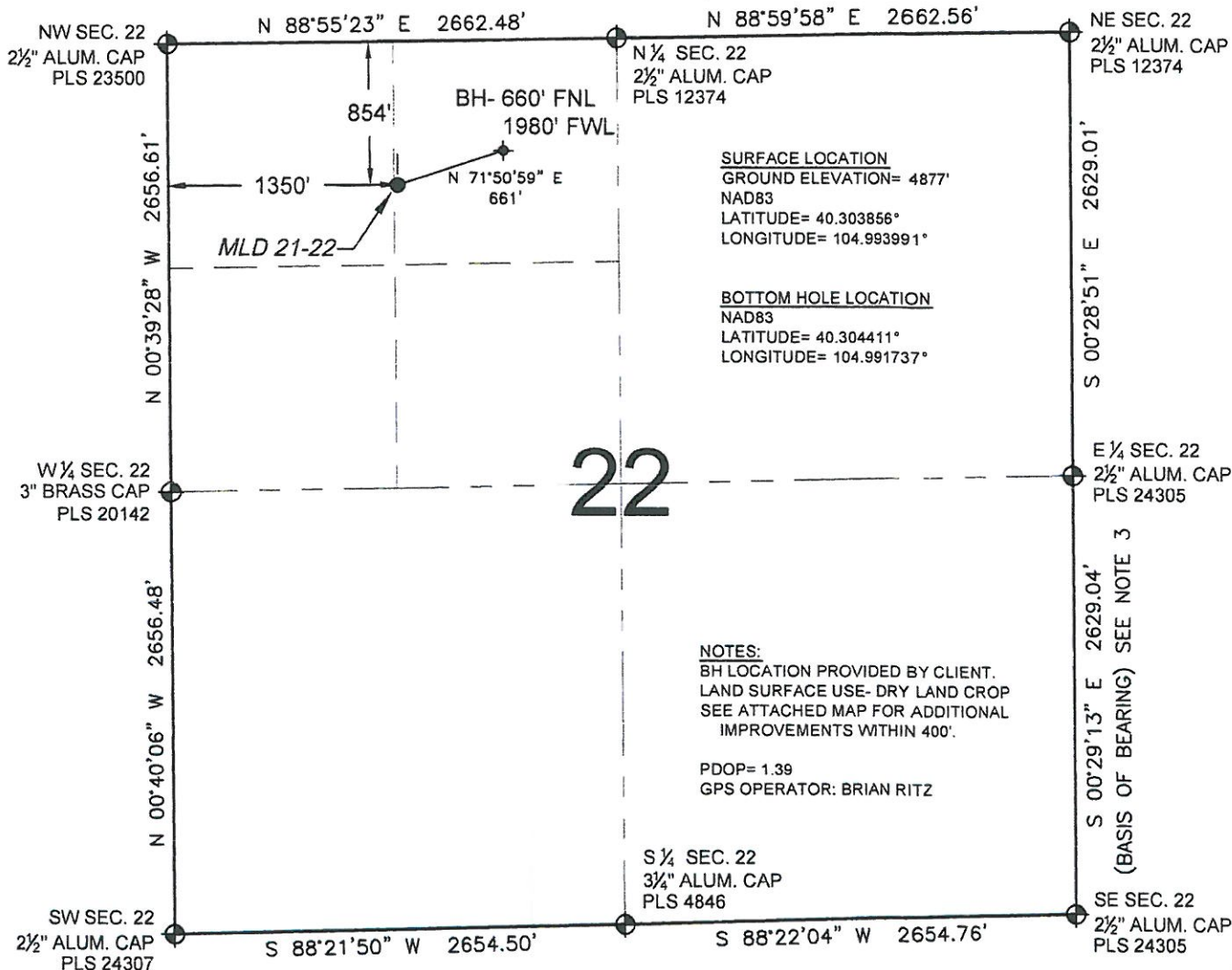


WELL LOCATION CERTIFICATE: MLD 21-22

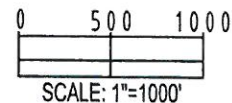
SECTION 22, TOWNSHIP 4 NORTH, RANGE 68 WEST, 6TH P.M.

● = PROPOSED WELL ◆ = EXISTING WELL

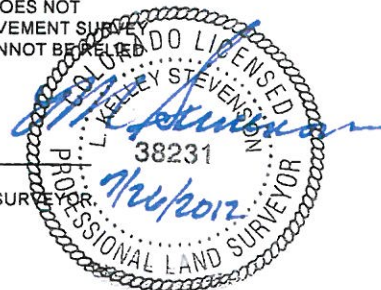
