TIH circulate to 6893'. TIH w/ CIBP and set @Set 6660', dump bail 2 sks cmt . Pressure test casing, isolate casing leak 2768- 2793', cut casing @ 3796' psi, TOO. TIH with casing patch and new 4 1/2" casing, work patch over stub, test casing and patch to 2000 psi for 15 min, test good.

TIH with 1 1/4" annular cement string, tag original cmt @ 3784', pump 395 sks 13.0# Varicem, pulled EOT to 2847', pumped 412 sks 12.0# Varicem, circulate 12 bbl to surface.

Run CBL from 3950 to surface
