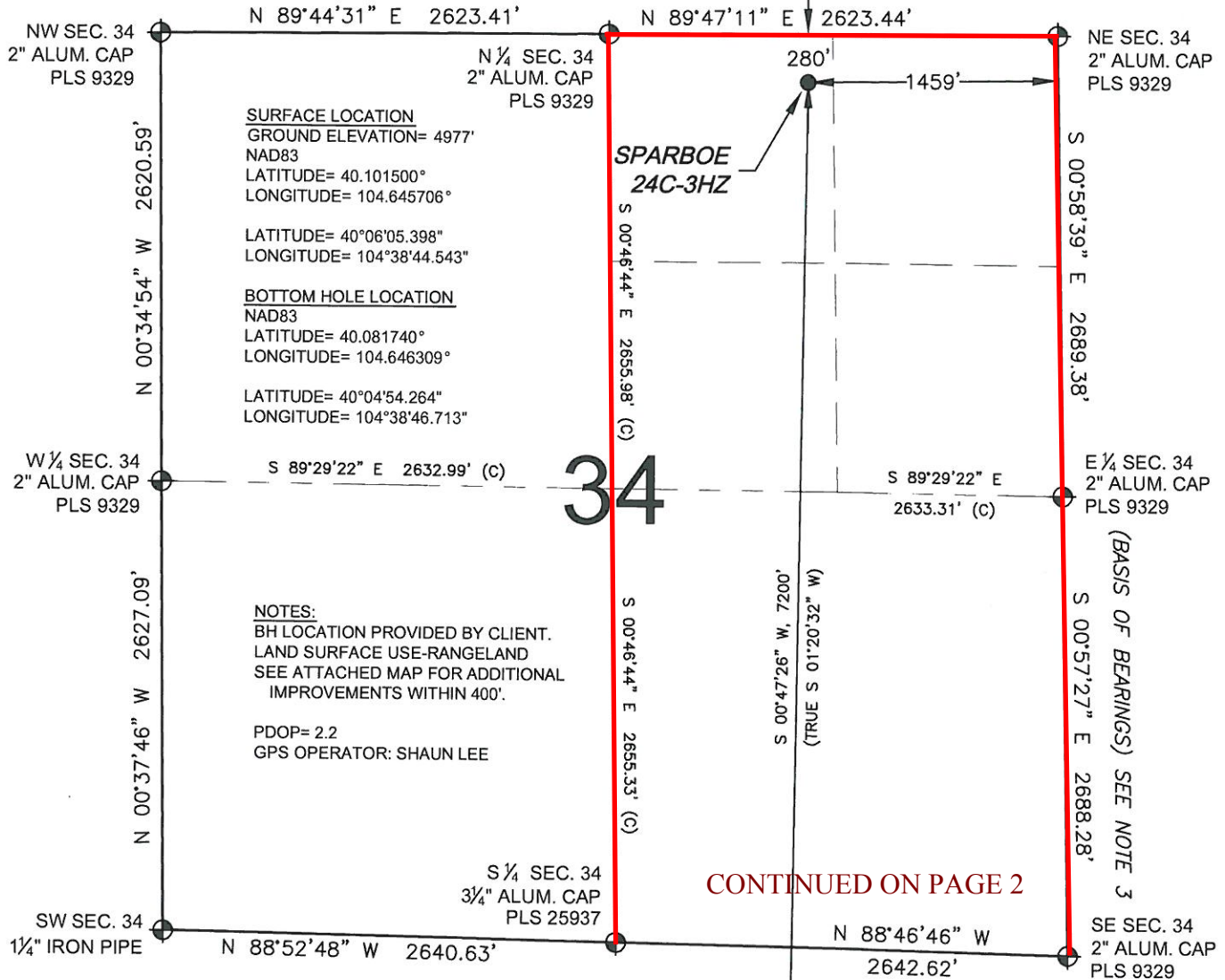

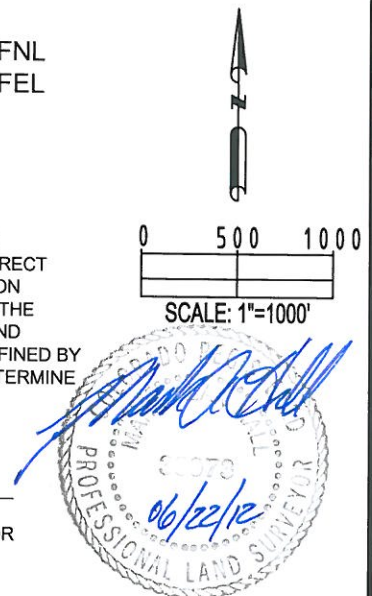

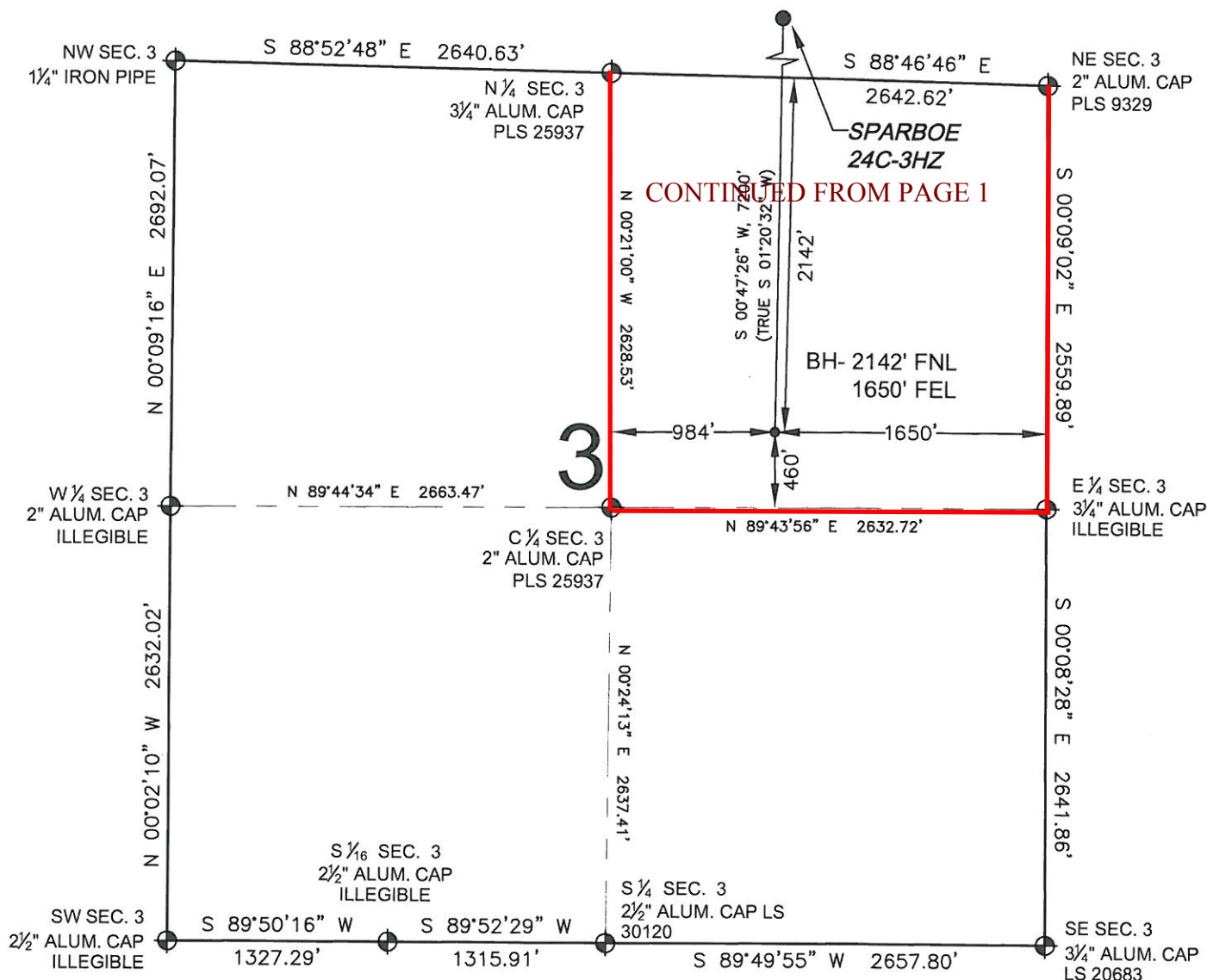

WELL LOCATION CERTIFICATE: SPARBOE 24C-3HZ

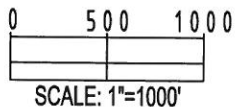
