RECORDATION NOTICE AND
MEMORANDUM OF OIL AND GAS LEASE

THIS RECORDATION NOTICE AND MEMORANDUM OF OIL AND GAS LEASE, made and entered into as of this 8th day of April, 2008, by and between **EXXON MOBIL CORPORATION**, whose mailing addresses are P. O. Box 4610, Houston, Texas 77210-4610 Attention: Western Land, (hereinafter called "LESSOR"), and **ANTERO RESOURCES PICEANCE CORPORATION**, whose mailing address is 1625 17th Street, Suite 300, Denver, Colorado 80202 (hereinafter called "LESSEE").

Lessor, in consideration of the sum of One Hundred and 00/100 Dollars (\$100.00) in hand paid, and other good and valuable considerations, of the royalties and of the other agreements of Lessee provided and contained in that certain Oil and Gas Lease of even date herewith, the receipt and sufficiency of which are hereafter acknowledged, does hereby GRANT, LEASE and LET, subject to the terms and conditions set forth in said Oil and Gas Lease, exclusively unto Lessee and Lessee's successors and assigns, for the sole and only purpose of investigating, exploring, prospecting, drilling, and operating for and producing oil and gas, associated liquid and gaseous hydrocarbons and other minerals contemporaneously produced with said oil and gas, including, but not limited to, sulphur; laying pipelines and building tanks, communication lines and other structures thereon and maintaining such works to produce, save, take care of, treat, store, transport and own such products obtained hereunder; and, for constructing roads and bridges necessary for operations hereunder, in and to the land described in Exhibit "A" attached hereto and hereinafter referred to as the "Leased Premises".

The terms hereof shall commence on the date of said Oil and Gas Lease and continue, subject to termination as therein provided, for a period of Eighteen (18) Months and so long thereafter as provided in said Oil and Gas Lease. 


