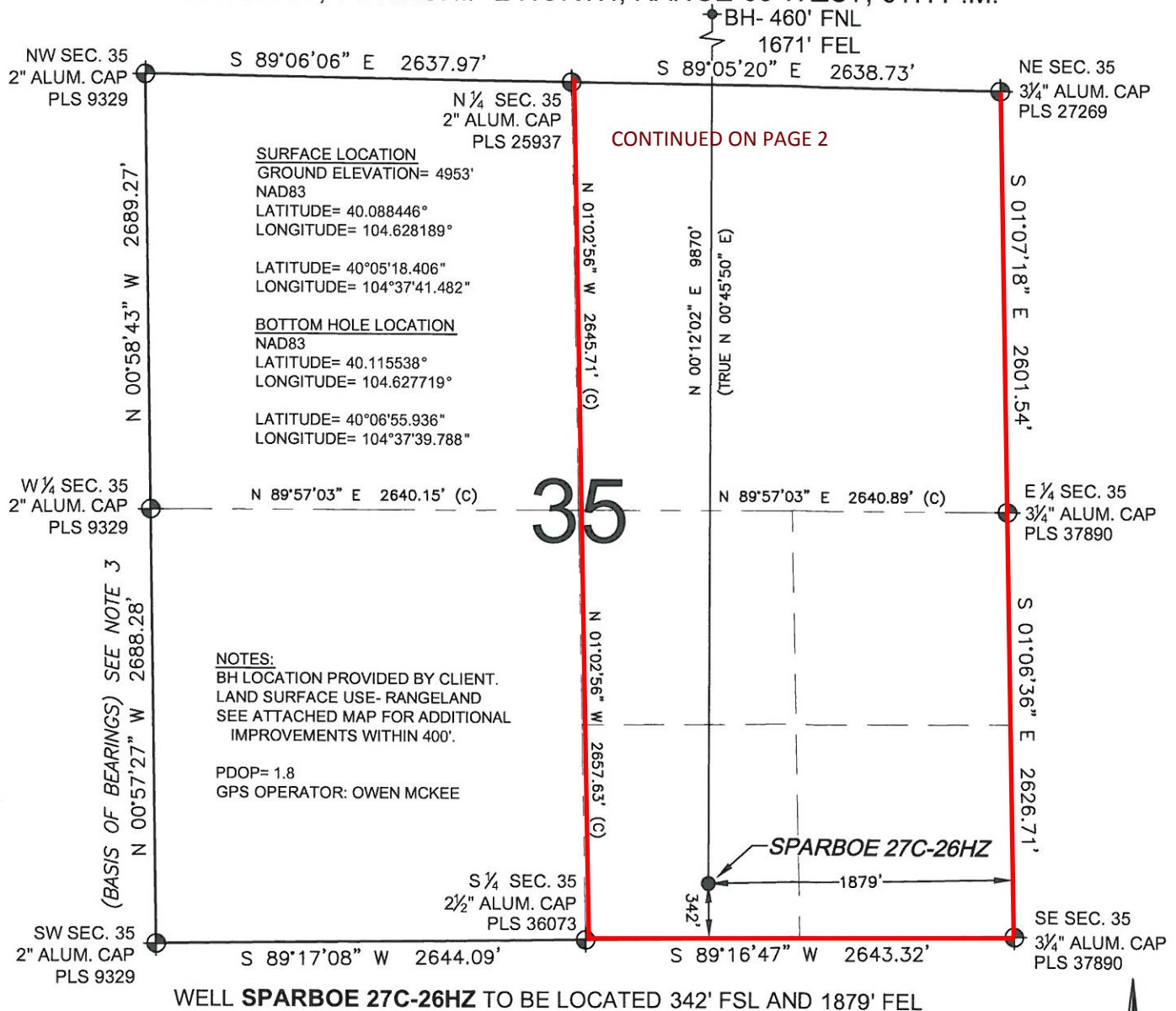

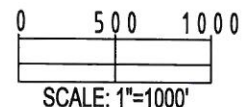
WELL LOCATION CERTIFICATE: SPARBOE 27C-26HZ

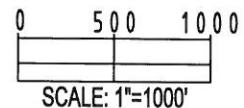
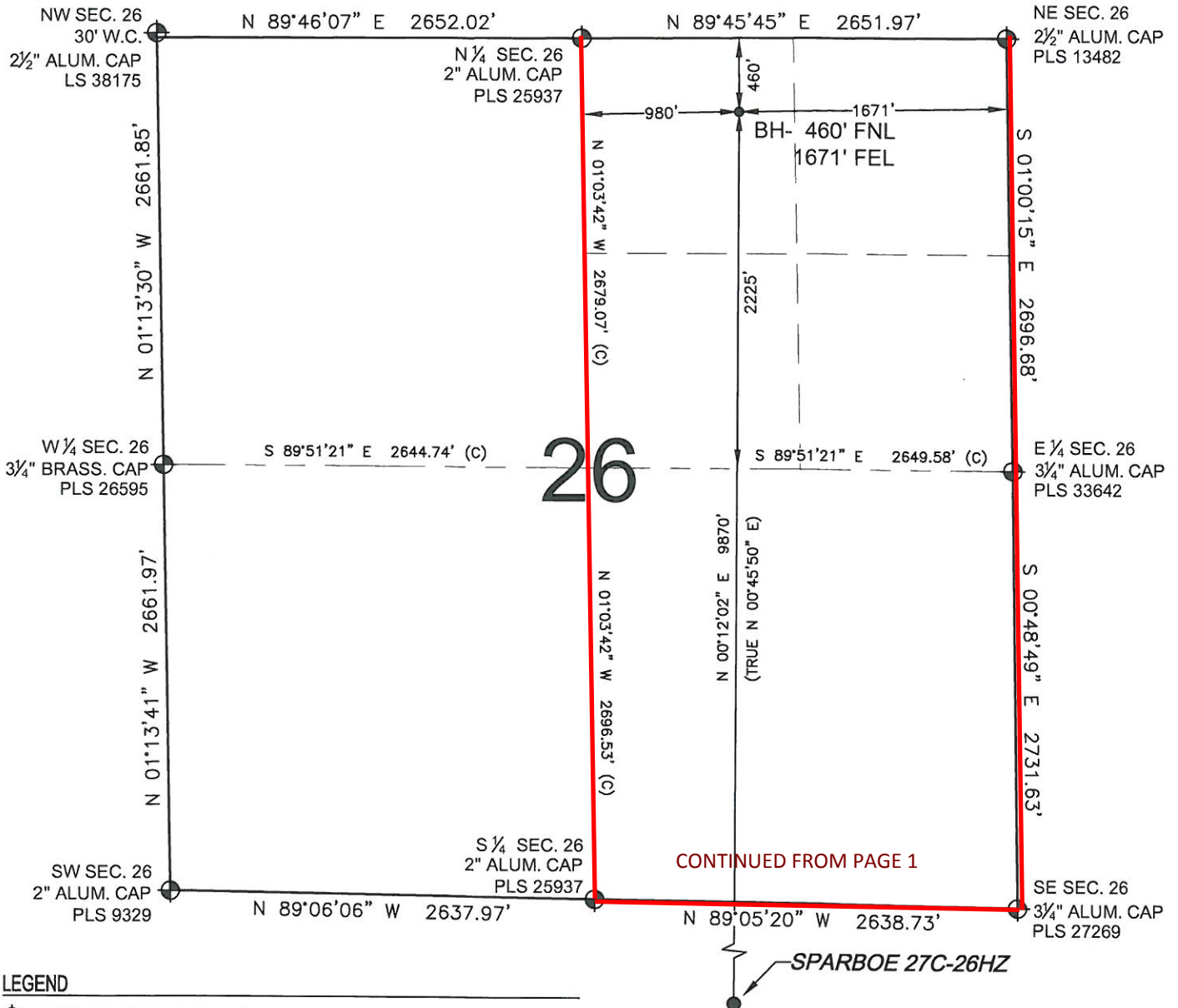
