Complaint based inspection of API #05-001-09439, HSR-State #6-16. Complaint cited popping noises similar to firecrackers coming from the well. No sounds, discharges, or leaks were observed. Home construction nearby included some compressed air nailers that generated popping noises. At approximately 11:10 the separator started flowing resulting in a loud whistling sound that lasted approximately 20 minutes. This well is a few steps away from a tee box on one side and a fairway on the other side and is observed closely by a large number of golfers.
