Please find the attached well location plat, directional plan, drilling plan, surface use plan, topo maps, construction layouts and related documents for the above referenced well.

Encana Oil & Gas (USA), Inc. respectfully requests to commingle the production on the WF I36 596, WF P36 596, WF I25A 596 and WF I25 596 wells pads containing the lease numbers COC60234 and COC44963. This request to commingle involves only the two referenced leases that contain 100% federal ownership with the same fixed royalty rate and revenue distribution. Encana is the sole operator in this area, so no signed agreement is necessary at this time. The leases are capable of production in paying quantities. The proposed commingling application will measure production originating from the above referenced leases through a common separator as described in the attached documentation. Please see the attached documentation regarding proposed production allocation plans that assures the BLM's ability to verify and account for the proposed commingled production and includes considerations relevant to the environment and public interest.
