Kerr-McGee Oil & Gas Onshore LP ("KMG") intends to propose the drilling, completion and operation of the Reigle 27N-4HZ horizontal well with a designated horizontal wellbore spacing unit pursuant to Rule 318A.a.(4)D. of the Colorado Oil and Gas Conservation Commission ("COGCC") Rules and Regulations. KMG hereby gives Notice of said horizontal well and horizontal wellbore spacing unit pursuant to COGCC Rule 318A.e.(6).

Information for this well is as follows:

1. **Surface Location:**
The well will be drilled from a surface location 463' FSL and 2406' FEL of Section 4, T2N-R65W.
2. **Target Formation:**
The well will be drilled horizontally into and produce from the Niobrara formation. The wellbore lateral will enter the Target Formation at 460' FSL and 1450' FEL of Section 4, T2N-R25W.
3. **Bottomhole Location:**
The bottomhole or terminus of the wellbore lateral will be at 460' FNL and 1450' FEL of Section 4, T2N-R65W.

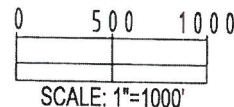
WELL LOCATION CERTIFICATE: REIGLE 27N-4HZ
