Hi Brenda,

Thanks for working with us to develop these BMPs for the amended Deal Gulch 1-16 location. I've included the edited language below.

Pad location: **Deal Gulch 1-16, T5N, R90W, section at 40.387986 , -107.498303**
Document #: 400313505

Wildlife concerns: The proposed pad location is within Elk Winter Concentration Area. Based on the above wildlife concerns, CPW recommends the following BMPs:

1. Construct the pad and drill the well outside of the period between December 1 and April 15 for elk.
2. Construct and or drill any subsequent wells outside the period between December 1 and April 15 for elk.
3. Conduct post-development well site visitations between the hours of 10:00am and 3:00pm and reduce well site visitations between December 1 and April 15; emergencies exempted.
4. Shell agrees to be in noise abatement compliance with COGCC Rule 802.c for the "Industrial" zone during construction, drilling, and completion of the well, and in compliance with the "Residential/Agricultural/Rural" zone during production operations.
5. Interim and final reclamation will match existing communities.

6. Include a weed management plan and implement the plan as part of reclamation.
7. As much as is practicable, build access road to the minimal width and improvement standards.
8. Install and utilize bear-proof dumpsters and trash receptacles for all food-related trash on location, following COGCC Rule 1204 a-1.

CPW would appreciate your concurrence with the proposed BMP's. Form 2A comments for this location are due at midnight on September 17, 2012. Please let me know if you have questions.
