

In accordance with a request from MAC NEUMANN with PDC ENERGY, INC. King Surveyors Inc. has determined the surface location of the STONEBRAKER 28V-234 to be 2000' from the NORTH line and 250' from the EAST line, the landing point to be 1800' from the NORTH line and 500' from the EAST line and the bottom hole to be 1800' from the NORTH line and 500' from the WEST line, as measured at right angles, from the section lines of Section 28, Township 2 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 6-19-2012, for and on behalf of PDC ENERGY, INC., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
