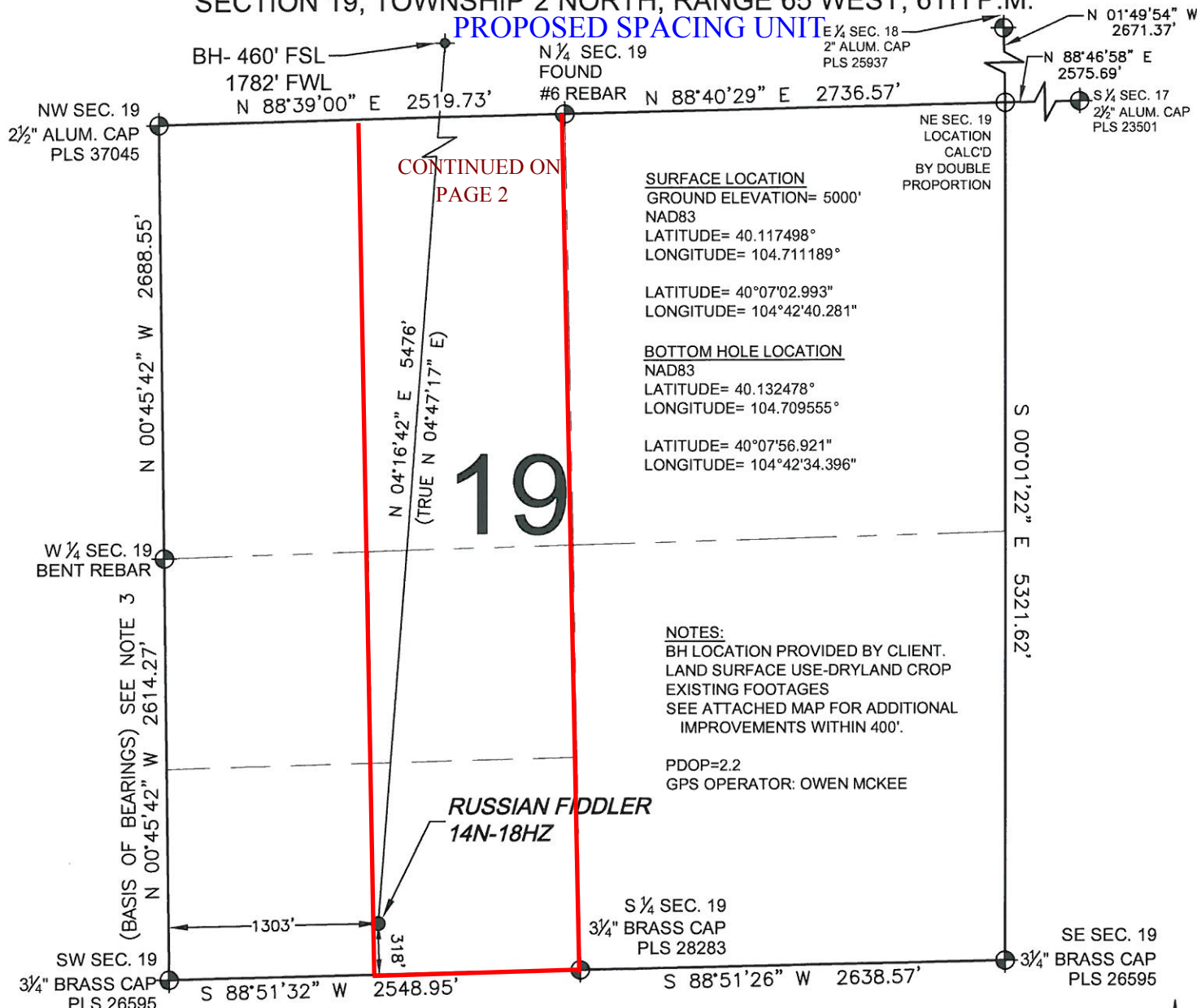

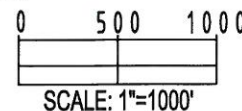
PROPOSED SPACING UNIT

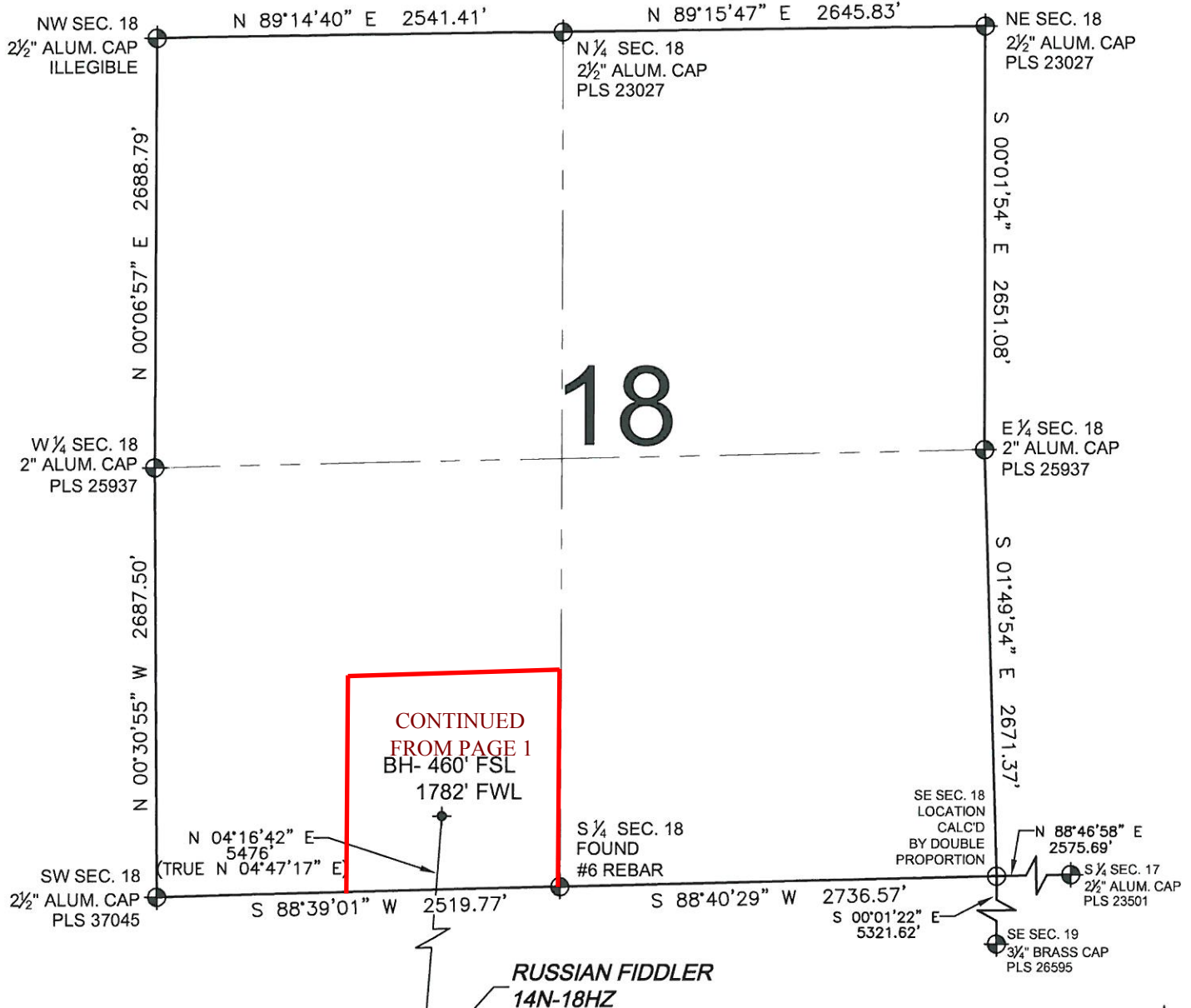

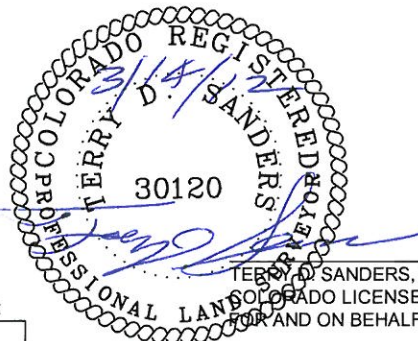
