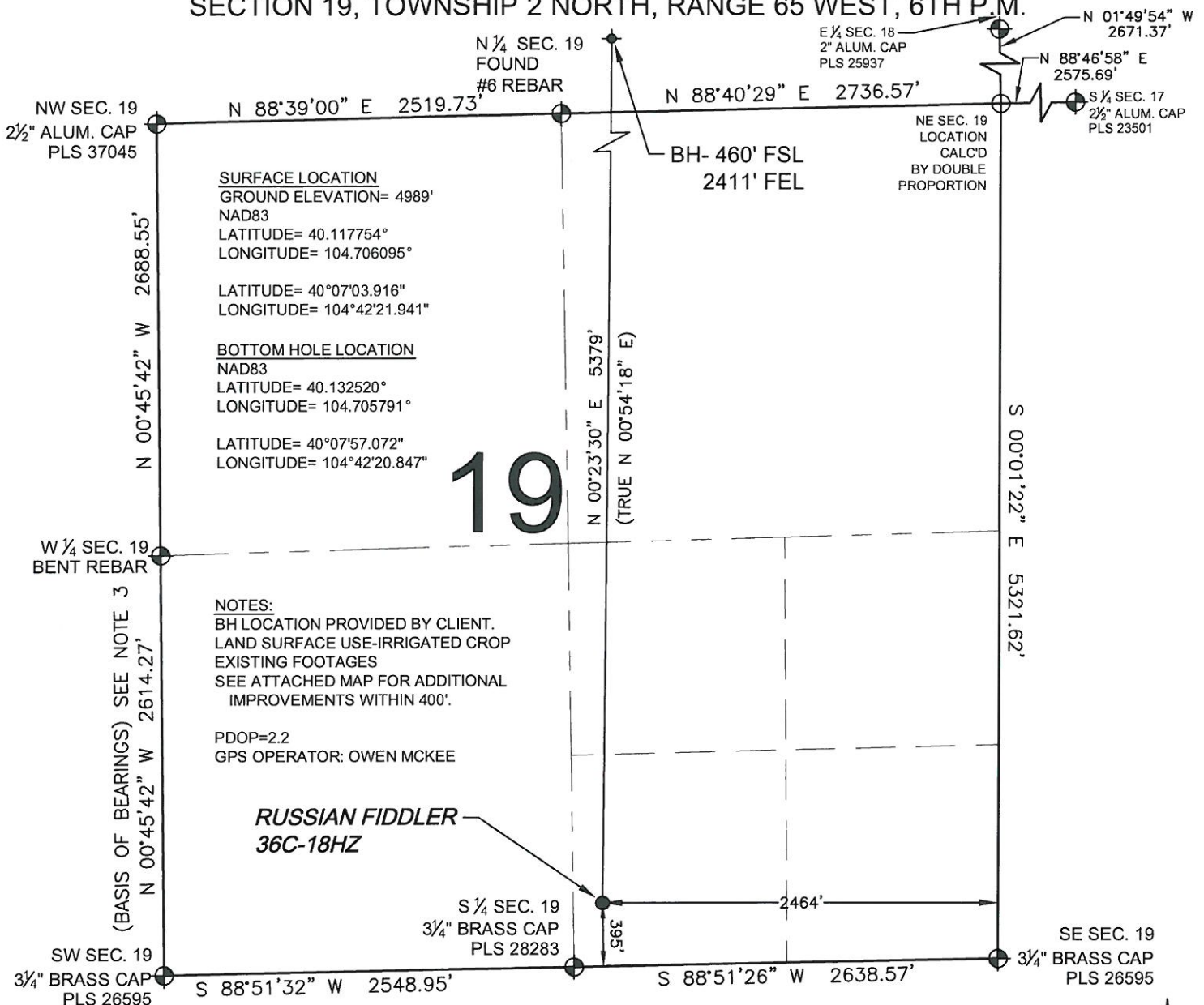


WELL LOCATION CERTIFICATE: RUSSIAN FIDDLER 36C-18HZ

SECTION 19, TOWNSHIP 2 NORTH, RANGE 65 WEST, 6TH P.M.

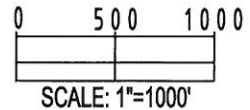


WELL RUSSIAN FIDDLER 36C-18HZ TO BE LOCATED 395' FSL & 2464' FEL.

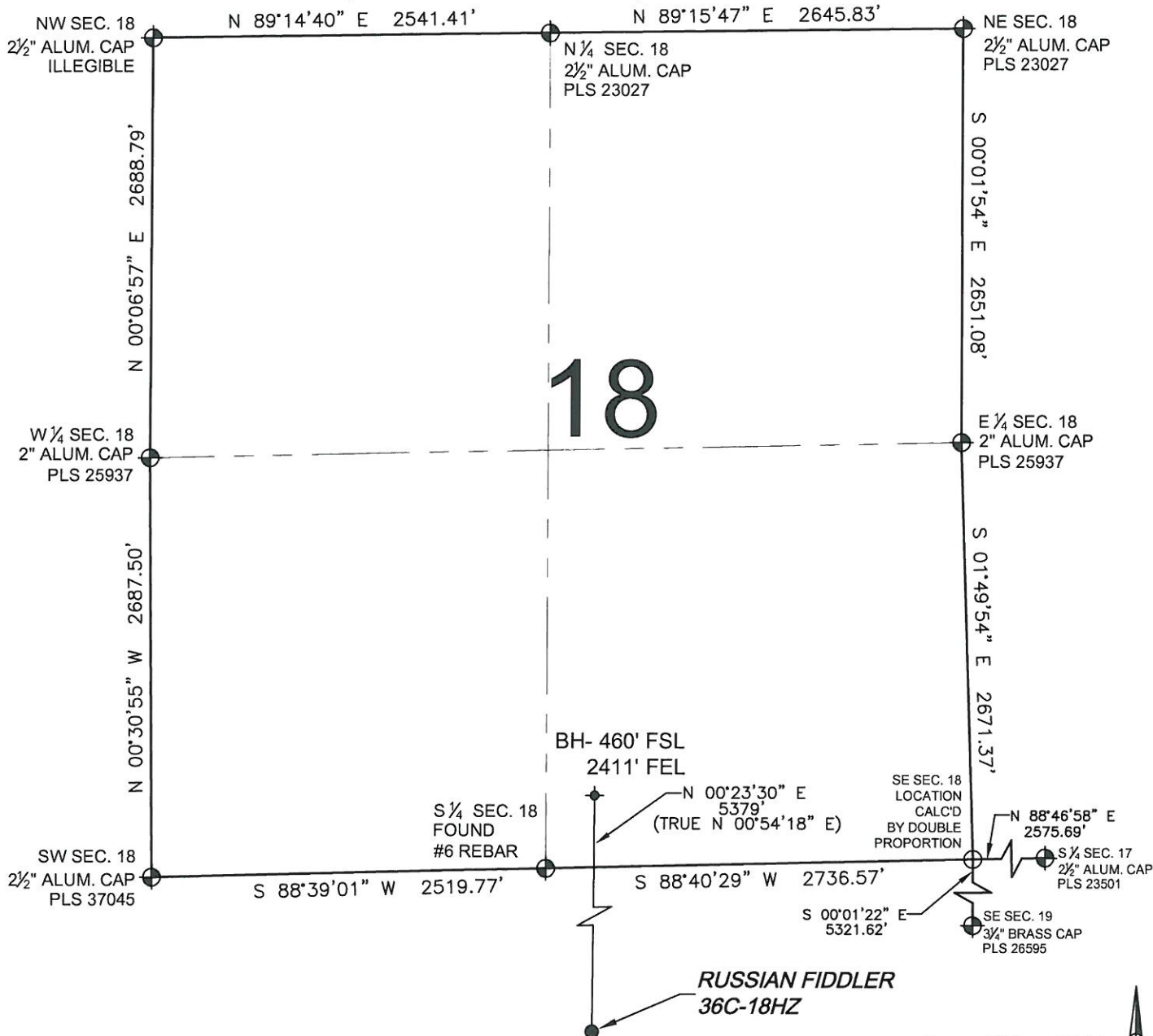

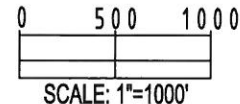
