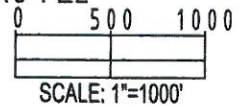

WELL MILLENSIFER FED 37N-E30HZ TO BE LOCATED 473' FNL AND 2010' FEL

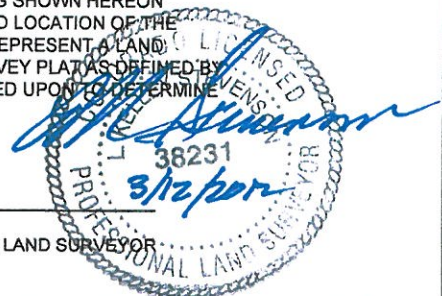
