Squeeze work occurred on the 608-41 well to isolate possible water producing zones. A CIBP was set at 7,260' with 2 sxs cement on top, and a retainer set at 6,630'. 1st squeeze: 50 sxs. 2nd squeeze: 127 sxs. Well was circulated clean, the CIBP was pushed to 8,292', and tubing was relanded at 7,986'. Also, this Form 5A will correct the producing formation that is listed on the original Form 5A dated 1/17/2001.
