Lily,

Neither version of this sundry contains enough information for me to approve. I will need to review all data pertinent to closure of this pit to demonstrate compliance with Table 910-1 levels.

Please resubmit January 2012 sundry with complete supporting information so it can be reviewed:

1. Site map, including confirmation soil sampling locations and sample names to demonstrate that impacted material was removed from the pit.

2. Analytical results from confirmation soil samples to demonstrate compliance with Table 910-1 parameters, including sample depth, sample date, and what stage in closure process samples were collected (pit contents, pit bottom confirmation samples, background, post-reclamation activities, etc)
3. Soil sampling method for all types of samples collected and if samples were composited or discrete.
4. Number of samples collected relative to volume of pit contents and exposed surface after contents removed (include pit dimensions)
5. Specific information on disposal of impacted soils, including volume, final destination, haul tickets.
6. Background soil sample location(s) plotted on site diagram. If more than one background sample was collected, provide all background analytical results.
7. The sundry form should "request that background concentrations be considered in lieu of Table 910-1 levels". This is far preferable verbiage to that in the October 2010 version which stated "Oxy's sundry will waive the COGCC Table 910-1 concentrations" and "Oxy's Sundry notice will apply different standards to the COGCC Table 910-1 concentration levels....."
