Hi,

May I have permission to correct the distances on the form 2 to match the 2A. I.e. On the 2, #17. Distance to the nearest... from 447 to 522 (building). Then in the surface and minerals tab you show that the total acres in the lease is 122, yet you've entered and entire mineral lease description as all of section 5 except a portion of the SW/SW which would imply that your acreage is closer to 640. (I think we had the same problem on some of the other Varra wells, but I don't recall what we did to correct it)). Then the SUA that you have attached is in metes and bounds so you should have included a lease map. So I need permission to correct #17 from 447 to 522; a corrected lease description; and a lease map.

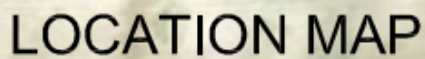
