Storm Water/Erosion Control	<p>Storm Water management plans(SWMP) are in place to comply with both Colorado Depaartment of Public Health and Environment(CDPHE) and Colorado Oil and Gas Conservation Commission(COGCC) storm water discharge permits. The construction layout submitted with the original Form 2A for this location details Best Management Practices that were implemented during the initial construction. Note that BMP's may be removed, altered, or replaced with the changing conditions in the field and the SWMP will be updated accordingly. The BMP's prescribed for the initial construction phase include, but are not limited to:</p> <ul style="list-style-type: none"> -Construct diversion ditch -Sediment Reservoirs -Check dams -Level spreaders -Stabilized construction entrance -Slash -Sediment Traps -Wattles -Terrace -Secondary containment berms -Detention pond

Drill subsequent wells outside the period between Decemeber 1 and April 15 for elk. 3. Conduct post-development well site visitations between the hours of 10am and 3pm and reduce well site visitations between the period of December 1 and April 15; emergencies exempted. 4. Shell agrees to be in noise abatement compliance with COGCC rule 802.c for the "Industrial" zone during construction, drilling , and completion operations, and in compliance with the "Residential/Agricultural/Rural" zone during production. 5. Interim and Final reclamation will match existing communities. 6. This will be a multi-well pad. Interim reclamation will commence once all proposed wells have been drilled and completed from this location. 7. A weed managment plan will be implemented as part of reclamation. 8. Bear-proof dumpsters and trash receptacles will be utilized for all food-related trash on location, following COGCC rule 1204 a-1. 9. Access road was built to the minimum width and improvment standards as much as practicable.
