Flow line needs to be cleared with fresh water--tested to 50 Psi and held for 5 minutes. No bleed off allowed. If bleed-off occurs, locate leak or leaks repair line and repeat the process. When no flow line leaks occur--cut off flow line and cap 4 ft below surface. Notify COGCC inspector 48 hours before testing to see if he wants to witness the process. Remove battery equipment and remediate the area. Remove all berm and road materials. Follow procedures for remediation and remove and rip the access road to battery and wellsite. If surface owner wants to keep lease roads contact inspector for procedure. Such requests may be granted by director approval.	precupj	10/19/2012
