Please find attached the No Further Action letter for the pit closure of Pit Facility ID #s 428039 and 428038 on the Puckett's Figure Four Ranch 499-14-27 well pad (Location ID: 316656). The project will be closed and the status of both pit facilities will be changed to Closed (CL) in the database corresponding scout cards. Consideration was given to the arsenic concentrations that are higher than COGCC Table 910-1 value but within the range of background samples in the vicinity of this site.

A couple of minor comments regarding **14-27**:

- Consideration to background levels in native soils must be requested via Form 04 (not only notified). It may look like a matter of basic communication but the EPS will review the request and may approve it or deny it.
- Form 27 stated that ". Interim and final reclamation activities will be carried out in accordance with COGCC 1000 Series requirements, and will be documented accordingly." If it wasn't because of the comment in the form 04 "Approximately 600 yds<sup>3</sup> were pushed into the pit excavation prior to backfilling", we would not know if the pit had been backfilled and reclaimed. Please, when submitting Notices of Completion, comment briefly on reclamation activities for completeness.
