Premium oil company intends to plug & Abandon the above Well by filling the hole with shale from a TD of 2,620 ft to the bottom of the 8 5/8" surface casing @ 426 ft. A cement plug will be placed at 426 ft and the remaining hole & casing filled with shale. An appropriate marker will be cemented at the surface. The well site will be reclaimed, seeded with a mixture of seed suited for the area.

The P&A will be done when a workover of cable tool rig is available to move on the well site.

COA - The cement plug at 426' should have 50' cement inside the surface casing and 50' cement below the shoe for 100' total plug length. Also need a 50' surface cement plug. MLH

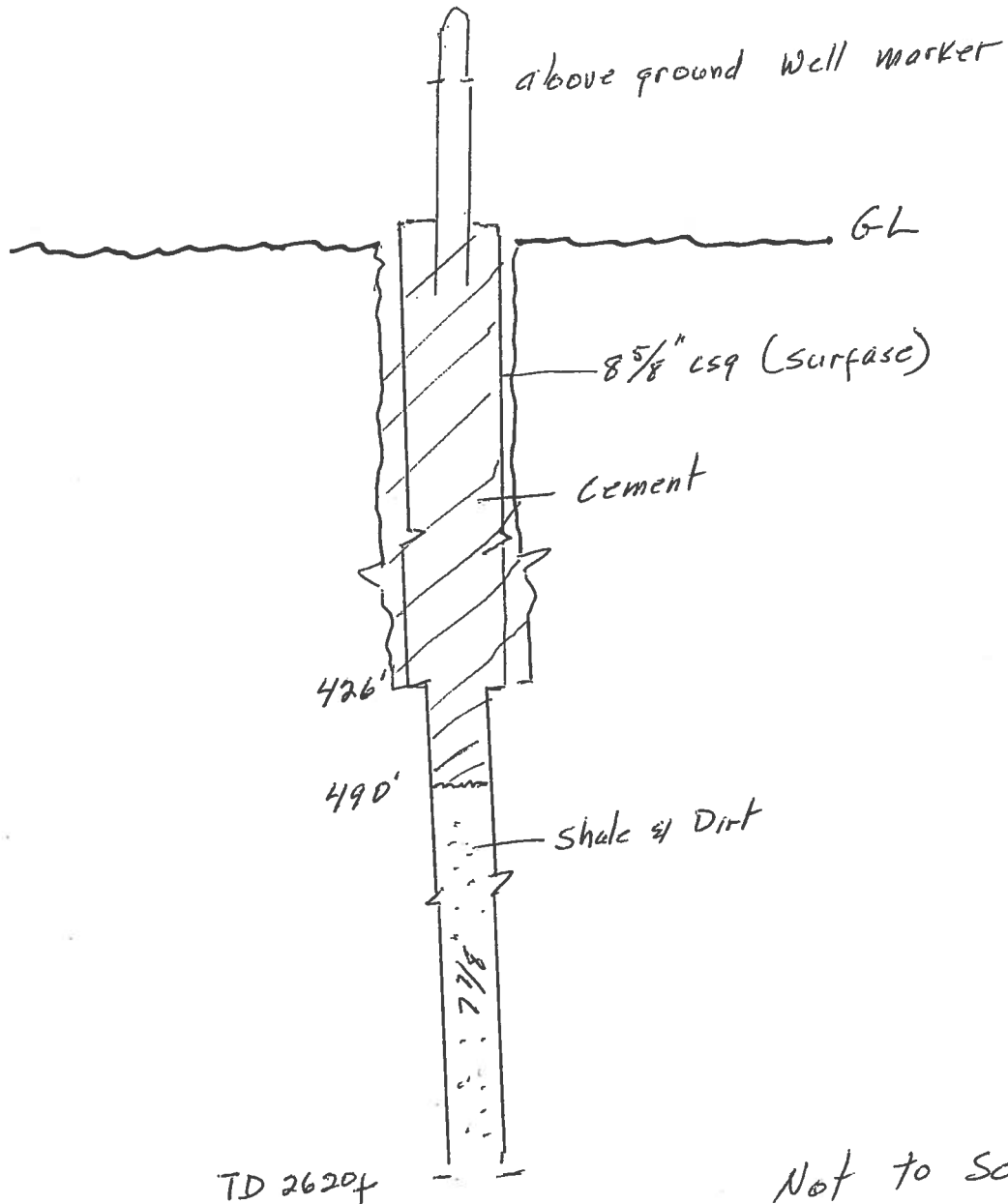
