33. Comments Nearest surface utility (980') is a power line that runs north-south along the east side of Morgan County Road 17. Nearest property line (990') is to the northern edge of the SW/4 of section 13, T1N R57W. Nearest well permitted/completed in the same formation (1260') is the L Clar #2. This permit is being submitted with a Form 33, Injection Well Permit Application. The L Clar #4 will be converted to a D sand water injection well in the D Sand Enhanced Recovery Unit that was approved under COGCC order 26-60 on May 21, 1990. A Form 2A is not required for this recompletion because no pit will be constructed and there will be no additional surface disturbance beyond the originally disturbed area. No conductor casing was used when this well was drilled; the casing consists of surface casing and a production string.
