DeAnne,

I am reviewing the Form 2A location assessment for the Bayswater Exploration and Production Kaiser Facility 6-10. Please address the following.

1. Facility: The Form 2A facilities list should include all existing and planned facilities for the location. Since it appears this location is now planned to handle 8 wells, please review the facilities list on the Form 2A and confirm it is correct or provide a revised facilities count. **I verified with Bayswater..... 6 oil tanks, 3 water tanks, 3 separator, 1 VOC combustor.**
2. Sensitive Area Designation: Data from a group of water wells in the NWNW Section 10 indicate that shallow ground water is likely present - I changed the Sensitive Area Designation to Yes and changed the depth to water to 20 feet. **Agree**
3. Distance to water well: We discussed revision of the Location and Hydrology Drawings and revision of the distance to water well this morning. **Exhibit attached.**
